A Hipped-roof Victorian town house, the two-and-a-half frame structure is notable for its twelve-sided corner tower of the type popularized by the Queen Anne style of about 1860-1890. Interior lattice-work in door openings and mantle detailing have a delicacy reflected in the imbricated shingles which cover the exterior of the building. A restrained square building, the North House tower provides an emphasis on the corner which contributes to the rhythmic, integrated urban street scape.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two-and-a-half story frame house on the southwest corner of Goldsborough Street and Hanson Street faces north. The building's nine-sided tower at the corner, provides an effective termination to this block of Goldsborough Street with its large, closely-spaced houses standing beside the sidewalk.

The main block of the dwelling is two bays wide and as deep as it is wide. The roof is hipped. A wide jerkin headed dormer protrudes from the center of the north roof slope; its single window is square with ten small panes in both sashes.

Windows throughout the house have one over one sashes and louvered shutters. They are situated one per bay excepting in the east facade where a three-sided bay window is used.

The tower is topped with a twelve-sided, conical roof and a finial. A flare marks the second floor line. Windows, three per floor, are tall and narrow.

The main entrance, with overlight and sidelights, has a door with five tiers of panels. A deep porch shelters the front facade. Its shallow hipped roof extends to the tower, and is supported by stout round columns, which replace the originals.

Two rooms deep and one room wide, the house has a side stair hall. Back to back fireplaces are situated between the rooms. The tall brick chimney serving them has a flaring cap.

The building was originally constructed with a narrow rear ell. In the early twentieth century an addition to accommodate a medical office was built to the east side of the ell.

Mantles on the formal, first floor rooms are generously decorated with applied neo-classical details - urns, festoons, and fluted columns. Hearths are ornamental tile. The delicacy of the mantle detailing is repeated in exquisite lattice-work in two double doorways on the first floor. Window and doors are framed with symmetrically molded trim which has corner blocks decorated with a bull's eye.

Rising to the third floor, the stair has a molded closed string course and mahogany newel-topped with an urn and hand rail.

The house is covered with wooden shingles in an imbricated pattern. Roof is green and siding is white. The front door is red. Beautifully maintained, the house used as a single family dwelling.

John C. North and his wife Mary bought their home in 1924 and have lived here since then. The property which they acquired from Barbara F. Davidson, a widow, and James P. Davidson fronted 45 feet on the south side of Goldsborough Street and 100 feet along the west side of Hanson Street. Dr. Charles L. Davidson, the husband of Barbara, had owned the property since 1901 when he paid \$3600.00 to Joshua and Sarah Wright for it. Dr. Davidson was a much-beloved physician and was instrumental in the organization of The Emergency Hospital, Easton's first. The Wrights bought the house and premises in 1891 for \$1500.00 from Albert Hughes and the Hughes paid \$900.00 for the same property in 1886 from Mary, Hattie, and William and J. E. G. Webb.






