Located on the east side of Route 33, approximately one tenth of a mile north of Pot Pie Road. The church has a gable roof with one gable facing Route 33 and another facing south. There is a square entrance and bell tower two stories high with a conical roof. The south face of the tower has a double six-panel door and a double window with 2-over-2 lights. The facade to the west has three tall 2-over-2 lights. The facade to the west has three tall 2-over-2 windows and there is a small 2-over-2 window in the west face of the tower. The facade to south has decorative shingles (diamond and fish scale) in the gable. There was also a small round window that has been removed and patched.

NOTES: In 1851, 64/42 William L Wrightson conveyed to Joseph Bruff and other trustees of the "Asbury Chapel"--formerly "Kersey's Meeting House"-- certain land which was for the use of a colored society or congregation now known as St. John's Meeting House; however, the land was never conveyed to St. Johns. Asbury ME Church has now sold their land adjoining the Wrightson property to St. Johns. They wish to wrap up the whole package and this deed is for two lots, 1851, 64/142 and the church building and land.



St. John's U.M. Church stands 20' from the east side of Rt. 33 at Wittman. It is a handsome structure. Originally clapboard it is now covered with aluminium siding (white). The entrance is on the south side. The double oak doors are located at the southeast corner of the building. The entrance foyer is 6½' square and is part of a short spire that now houses an enclosed belfry. The original bell for this church is now located on the lawn. The church now has electronic chimes. The church has 4-over-4 oblong redglass windows(8'). Two on each side and 2 on the west gable. The interior has circular pews (oak).

STATEMENT OF SIGNIFICANCE

St. John's U.M. Church is an example of another white Methodist church that was given to blacks. This church became an all black congregation in 1886. The church is attended by black watermen, farmers and packing house employees. The area is well known for its seafood industry. The church is well maintained and contains a number of fine oak pews that were built locally. The congregation has a better income than some Eastern Shore black congregations. This is insured by the activity of the Tilghman Island packing plant. Wittman is a predominately black community.


