The chain of title and architectural features for this two-story, wrought-nail frame house suggest it was erected during the first decade of the nineteenth century. Raised four- and six-panel doors, an enclosed winder stair, a raised panel stair soffit, and a vertical beaded board attic partition are several interior finishes that support the estimated date of construction. The exterior, on the other hand, has been thoroughly reworked, but in spite of the changes, the main house retains its basic form. The flush gable ends, a steeply pitched roof and a boxed cornice with bed molding are basically intact. However, the c. 1965 gable end additions, the aluminum siding and the solar heat panels have greatly compromised this once significant exterior.

John Dorgan purchased Lot 58 on which this house stands in June of 1782 from Jonathan Spencer (21/2659), and Dorgan retained ownership of the property until the late 1820s. Since this house is not included on the 1798 Federal tax assessment, it appears the dwelling was erected during the few years following the turn of the century. Lot 58 and the house passed to John Dorgan, Jr. in 1829 and then out of Dorgan family hands in 1848 (61/451).

Dorgan house description

The John Dorgan house, located at 217 East Chestnut Street, stands on the north side of the street along the St. Michaels waterfront. The c. 1800-1810 two-story frame house faces south with the main gable roof oriented on an east/west axis. Accompanying the house is a modern garage.

The two-story three-bay aluminum sheathed frame house is supported by a minimal brick foundation and is covered by a steeply pitched asphalt shingle roof. The gable ends are flush and the cornice is boxed and trimmed with bed molding. To both the east and west modern additions have been attached and a screened-in porch extends from the back of the house.

The south (main) facade is three bays across with three 6/6 sash lighting both floors. Louvered aluminum shutters flank each window. According to the present owner, Mr. James Howe, the front door was formerly located in the center bay before its relocation in the adjacent addition. Solar panels have been inserted in the south roof slope.

The east gable end is largely covered by the single-story c. 1965 addition. Two 3/3 windows light the second floor, while a pair of 2/2 sash light the attic and flank the replaced interior end brick chimney.

The rear face of the house is similarly detailed without any notable differences from the rest of the house. A large picture window has been cut through the first floor for a view of the harbor, while 6/6 sash windows light the second floor. The west gable end has two 2/2 sash attic lights.

The first floor interior of the main block has been remodeled and most of the original woodwork has been removed. The only significant feature is the enclosed winder stair which remains in the southwest corner. Four exposed steps rise to a four-panel door and winder steps. The handrail and newel post have been replaced, but the raised-panel stair box has remained intact. A small two-panel door opens into the closet space below the steps. Clearly visible are wrought-iron nails used in the stair construction.

The stair rises to a three-room second floor and the second floor banister survives with its molded handrail and rectangular balusters. The west half of the second floor comprises the main room, while the balance of the space is divided into two rooms. Raised six-panel doors separate the three rooms and are framed by finely molded surrounds with a small ovolo and small cavetto molding. The attic stair rises from the present bathroom and is enclosed with flat paneling. The four-panel door retains its spring latch.

The unaltered attic is divided into two rooms by a vertical beaded board partition with two raised panels above the doorway. The door is missing. The knee walls were framed in and small frames for hatch doors in the knee walls were installed, but the walls were never finished. The common rafter system is braced by lapped collar beams fastened with wrought nails. The peak joints of each rafter pair are also lapped and held together with wrought nails.

An example of the difficulty in understanding what happened, and why...Jonathan Spencer had bought lot 58 for £ 100 specie; on same day, John Dorgan bought the water-front half from Spencer for £ 3 specie; one year later Spencer sold the upper half (?) to Thomas Groves for £ 50 "current money"! And in 1784, Dorgan bought Groves' lot for £40 specie. Thus, in 1784 Dorgan owned all of 58 for which he had paid a total of £ 43 specie.

It is not possible to determine the length of Dorgan's lot exactly. It begins at a post on the line of lot 57 runs 60' to Chestnut Street, then "to the creek". There is probably 50 to 100 feet more land today (oyster-shell fill) than in 1782.

This is the first sale of this lot after the town lots had been put up for sale. The £ 100 specie is probably the highest price paid for any single lot in the town. (See note, below) ~~Though~~ the lot has the "standard" width of the town lots of 60', it was more than twice the length of the other town lots. There was a very active blacksmith shop on the Wetheral property from which the town was made up and it is possible that it could have been on this site.* Jonathan Spencer had previously purchased lot numbers 55, 56, and 57 on Water Street adjacent to #58. The prices paid for these lots were £ 10 "current money", £ 200 "current money", and £ 10 "specie" respectively.

Note: Money values, especially "current money" fluctuated widely during and after the Revolution; "hard money" or specie had the highest value.

This is the first sale of this lot. The p100 specie is probably the highest price paid for any single lot. There was a very active blacksmith shop on the Wetheral property (of which this lot is a part) and it is possible that the shop was located here. Jonathan Spencer had previously purchased lots 55 (p10 cm), 56 (p200 cm), and 57 (p10 sp). Considering the wide fluctuation of money during the Revolution and the difference in value between "current money" and "specie" it is difficult to determine the actual value of the various lots; however it would appear that, of the string of lots from 55-58, lots 56 and 58 had features that made them more valuable.







