**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

Beneath the long limbs of the Wye Oak stands a one and one-half story brick one-room building said to be the first public school on the Eastern Shore. It appears to date from around 1800, and looks almost identical to the small building now used by the Chamber of Commerce near Easton (called "Tilghman's Fortune").

One feature which differs is the placement of the chimney, slightly projecting (about 4") from its north gable. The various coats of paint are wearing away creating an uneven surface. It's three bay facade, laid in Flemish bond above an unmolded water table, has a central door with wood steps to the ground. The windows have 9/6 sash and louvered shutters, except the single dormer on the east side of the 'A' roof, with 6/6 sash, and the four pane casement in the south gable. The south and west sides have one window, although there appears to have been a door originally on the west, now blocked up. Curious use of all glazed headers appears in the old brickwork of the south gable.

The interior has simple period trim and a ladder to the loft.
