The Russell house is a relatively well preserved Victorian period dwelling with an original porch, doors, windows and interior woodwork. The center cross gable is lighted by a typical Gothic arched window. This modest center hall, single-pile house is a common form for the third quarter of the nineteenth century, and it is found repeatedly throughout St. Michaels. Like many other houses from the same era, the Russell house is a good example with simple period details which contributes to the overall significance of East Chestnut Street as well as the town.

The chain of title for the Russell house indicates a structure was erected shortly after Jasper Y. Tarr bought part of Lot 58 for \$50 from Oliver and Rachel Fairbank in 1872 (78/288). Three years later Jasper Tarr sold the same property to Thomas L. Dawson for \$500, which strongly suggests the improvement of the lot between 1872 and 1875 (207/149). Marion and Virginia Russell acquired the house and lot in 1963 from the estate of Owen C. Blades (390/40).

Russell house description

The Russell house, known historically as the Jasper Y Tarr house, is located at 215 East Chestnut Street in St. Michaels, Talbot County, Maryland. The c. 1872 two-and-a-half story cross-gabled frame house faces south with the principal gable running on an east/west axis.

Supported by a minimal brick pier foundation, the center hall house is sheathed with asbestos siding and covered by a steeply pitched asphalt shingle roof. A two-story two-bay by one-room service wing extends to the rear, while a flat roofed living room addition has been added to the rear.

The south (main) facade is a symmetrical elevation with a center entrance and flanking two over two sash windows. The heavily molded four-panel door is framed by sidelights and a three-light transom. The windows are flanked by louvered shutters. Lighting the second floor are three 2/2 sash windows, and the cross-gable is pierced by a Gothic arched 2/2 sash window. The eaves to the roof are extended with sloped soffits. Stuccoed brick stove stacks rise from each gable end. A turned post front porch covers the first floor, and it is trimmed with sawn corner brackets and a turned baluster handrail.

The east and west gable ends are essentially alike with windows on each floor flanking the interior end stove stacks.

Covering a large portion of the north (rear) elevation is the old two-story service wing detailed in the same manner as the main house. An interior stuccoed stack rises from the gable end.

The center stair hall separates two rooms on both floors, while an additional small room is located at the head of the stairs. The woodwork throughout the house remains relatively well preserved. The Victorian period stair is distinguished by a heavily turned newel post with a ball finial, a molded handrail, turned balusters, and a molded stringer. A small closet is located below the stair and is enclosed with a four-panel door with^a Victorian period latch. Four-panel doors open into the adjacent rooms which are fitted with mantels and molded baseboards. The mantels have fluted pilasters topped by bulls-eye blocks. The frieze is decorated with raised panels and a center bulls-eye. A plain mantel shelf is supported by simply curved brackets.

The second floor is plainly finished with an unheated small room at the head of the stair and modest-sized bedrooms to each side. A third bedroom is located above the old kitchen.

The old kitchen, now a utility room, is fitted with a plain post and lintel mantel, and a beaded board door cupboard is located to the left of the mantel..

The modern living room and kitchen additions were attached within the last twenty-five years and are undistinguished architecturally..

Significance

History and Support

The chain of title for the Russell house indicates a structure was erected shortly after Jasper Y Tarr bought part of Lot 58 for \$50 from Oliver and Rachel Fairbank in 1872 (Deed Book 78/228). Three years later Jasper Tarr sold the same property to Thomas L. Dawson for \$500, which strongly suggest the improvement of the property between 1872 and 1875 (Deed Book 207/149). Marion and Virginia Russell acquired the house and lot in 1963 from the estate of Owen C. Blades (Deed Book 390/40).

This lot consisted of the entire upper half of lot 58. When the lot was purchased by John Dorgin in 1784 he then owned the entire lot 58. The house on the corner of Chestnut and Water Streets is alleged to have been built by Oliver Fairbank (see above) according to Mrs. Lena Fairbank who lives on the other side of Water Street. She is in her late eighties and Oliver Fairbank was her grandfather.


