DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Wye Oak State Park presently consists of 21 acres. The original two 3/4-acre lots were purchased in 1939. A portion of the money was raised through public subscription and the balance was appropriated by the State Department of Forests and Parks.

The tree measures 50 feet in circumference at its widest point, which is one foot above ground level. Branch spread is 165 feet, and its total height is 95 feet.

STATEMENT OF SIGNIFICANCE

The Wye Oak was first brought to public attention in 1909, when a State Forester who photographed and measured the tree found it to be the largest specimen on record in the Eastern United States.

The remarkably good health of the tree is attributed to the foresight of such individuals as DeCoursey W. Thom, of Blakeford, Queen Anne's County, H. Stevenson Clopper, a tree expert, and J. Russell Smith, of Columbia University.

In 1914, Mr. Thom engaged a tree expert for general repair work and the removal of dead branches.

Additional repairs were needed in 1930, and Mr. Clopper, who had performed the initial task, undertook to trim out the dead wood and brace several of the larger limbs.

The Maryland Forestry Association paid for the materials and Mr. Clopper donated his services.

In 1947, Mr. Smith donated and applied 800 pounds of fertilizer to the tree.

On October 6, 1953, a large limb of the Wye Oak was torn off during a severe storm. Theodore McKeldin, then Governor of Maryland, had the wood made into gavels which were distributed to a number of State Judges.

Annual fertilization, trimming, necessary spraying and other maintenance on the Wye Oak is performed by the Department of Forests and Parks.

This huge white oak which stands alongside State Highway 622 in Wye Mills, Talbot County, is estimated to be approximately 400 years old.

The late Dr. Charles S. Sargent, one of America's noted tree botanists, rated it as the largest and finest specimen of white oak in the United States. The white oak is Maryland's State tree.

Pictures, descriptions and measurements of the Wye Oak are recorded in the "Hall of Fame" of the American Forestry Association, and in the publication, "Forest Trees in Maryland."


