The Robert G. Marshall house stands along East Chestnut Street in a line of contemporary frame houses that repeat similar late nineteenth-century features. The sidelighted entrance, the two-over-two sash windows, and the turned post porch with sawn brackets are consistent architectural elements that tie this dwelling with many others standing nearby.

The history of this corner lot is tied intimately to the development of the lot due north of it. The two lots were originally one until the large St. Mary's Square property was divided in 1853. At that time, Thomas Keithley retained the northern half. The corner lot changed four times between 1853 and 1871, and at each transfer the purchase price remained approximately the same. This would suggest no substantial improvements were added to the site during that period. In 1871 Mary E. Caulk purchased the lot for \$450 and evidently financed the construction of the two-story house soon after. At the estate settlement of Mary E. Caulk in 1926 the house and lot were sold to George Krill for \$1300.

Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The Robert G. Marshall house, also known as the Mary E. Caulk house, stands at 111 East Chestnut Street on the southwest corner of St. Mary's Square in St. Michaels, Talbot County, Maryland. The two-story, side hall/parlor house faces south with the principal gable oriented on an east/west axis.

Erected around 1871-1877, the two-story, three-bay frame house is supported by a minimal brick foundation and sheathed with a uniform layer of aluminum siding. The steeply pitched roof is covered with asphalt shingles. A service wing built during the second quarter of the twentieth century extends to the back of the house, and a single-story addition erected around 1969 is attached to the west gable end of the front block.

The south (main) facade is marked by three evenly spaced bays. The entrance is located in the westernmost bay where a four-panel door is framed by two-light sidelights and a multi-pane transom. The adjacent bays are filled with two-over-two sash window. A turned post porch stretches across the entire first floor and is decorated with Victorian sawn brackets. The second floor is lighted by three two-over-two sash windows.

The east gable end of the house is marked by a modern exterior brick chimney with a corbelled base and cap. Two-over-two sash windows light the first and second floors south of the stack. The eaves are extended and finished with a short return at the base. The west gable end is largely covered by the single-story frame addition, and likewise, the north (back) side of the main block is covered by the 1940s service wing.

The interior has been moderately remodeled, but the hall retains its Victorian style stair with a heavily turned newel post, turned balusters and a molded handrail. The stringer is also molded. The parlor has been reworked with modern materials.

The second floor retains its original pine floors as well as four-panel doors. A beaded board door opens into the enclosed attic stair.

SIGNIFICANCE

The Robert G. Marshall house stands along East Chestnut Street in a line of contemporary frame houses that repeat similar late nineteenth-century features. The sidelighted entrance, the two-over-two sash windows, and the turned post porch with sawn brackets are consistent features which link this dwelling with many of the others standing along East and West Chestnut streets.

HISTORY AND SUPPORT

The history of this corner lot is tied intimately to the development of the lot due north of it. The two lots were originally one until the large St. Mary's Square property was divided in 1853. (65/146) At that time, Thomas Keithley sold the southern half of the lot to Robert Lambdin for \$484, while Keithley retained the northern half. The corner lot changed hands four times between 1853 and 1871, and at each transfer the lot was sold for approximately the same amount. In 1871 Mary E. Caulk purchased the lot for \$450, which suggests no improvements had been made to the property. (77/307) The estate settlement of Mary E. Caulk included the sale of the St. Michaels house to George Krill for \$1300. (205/50)

Kurtz. 24 April 1797" Apparently, Elizabeth Man and Ann Dugin were daughters and heirs of Duncan Campbell.

The land was part of "Janes Progress".


