The research compiled on this Water Street lot indicates that Dawson Caulk, Jr. initiated the construction of this two-story, side hall/parlor frame dwelling around 1880 on his father's large harbor front lot. Dawson Caulk, Sr. purchased "Lot 54" from the estate of Samuel Harrison in 1845 and occupied the house now known as Magnolia Hall during the mid to late nineteenth century. It was evidently agreed to allow Dawson, Jr. to build a two-story frame house on the north edge of the lot, property which he formally purchased after his father's death. The clause in the title includes the statement, "...That lot of ground with improvements." The architectural features of the house agreed with the late nineteenth-century estimated date. Dawson Caulk continued to hold title to the property until his death, and the house was sold by his heirs in 1924.

The Dawson Caulk house, located at 409 Water Street, stands in the eastern residential district of St. Michaels, Talbot County, Maryland. The narrow lot stretches from Water Street to the edge of the St. Michaels harbor. Facing west the main gable roof of the two-story house is oriented on a north/south axis.

Built around 1880, the two-story, side hall, parlor frame dwelling is supported by a minimal brick foundation, and it is sheathed with a uniform layer of aluminum siding that imitates German siding. The steeply pitched gable roof is covered with asphalt shingles. Attached to the back of the house is a modern single-story frame wing.

The west (main) facade is an asymmetrical three-bay elevation with a side entrance and flanking four-over-four sash windows. Although the front door is a replacement it is framed by a single-pane transom and three-light sidelights. The four-over-four sash windows are flanked by artificial louvered shutters. Sheltering the first floor is a Tuscan columned hip roof porch that survives with a seamed tin roof. The second floor is lighted by three four-over-four sash windows that are framed by artificial shutters as well. Covering the boxed cornice is a metal soffit.

The south gable end is marked on the first floor by a modern bay window and an adjacent four-over-four sash window. The second floor and attic are lighted by a combination of four-over-four and six-over-six sash windows that flank the interior end brick stove stack. The eaves are extended slightly with short returns at the base.

The north gable end is marked by an asymmetrical two-bay elevation with six-over-six sash windows. The eave is treated in the same way.

Covering a large part of the east side is a single-story frame wing that was added during the 1970s.

The first floor interior has been remodeled with the removal of the hall partition to consolidate the hall and parlor into one large room. A heavily turned newel post and turned balusters support a molded handrail. A modern door opens into the space under the stair where a bathroom has been added. Fixed against the chimney breast is a late Victorian mantel with applied moldings. The room is also trimmed with period baseboard. The second floor was not seen.

Prepare both a summary paragraph of significance and a general statement of history and support.

The Dawson Caulk house dates from the late nineteenth century and follows a common house plan for the time. The two-story, side hall/parlor house type was erected countless times as a basic structure that was enlarged by side or rear additions. Although this example on Water Street has been remodeled with artificial exterior siding and the removal of the interior hall partition, the structure retains its basic integrity and contributes to the period architectural character of Water Street.

The chain-of-title for this lot indicates that the extant two-story frame house was probably erected around 1880 by Dawson Caulk, Jr. at the edge of a large harbor front property owned by his father, Dawson Caulk, Sr. The large lot is indicated on the 1877 St. Michaels town map with only one dwelling, the main house, on the site. After the death of Dawson Caulk, Sr. his heirs transferred formal ownership of a 120' by 30', "...lot of ground with improvments."(112/142) Dawson Caulk, Jr. evidently occupied the property until his death, and his heirs sold the dwelling in 1924 to Ella C. Mansfield.(199/464)


