## STATEMENT OF SIGNIFICANCE

The Moore farm was included in the survey of sites in 1970 due to its form, which follows the lines of those buildings constructed throughout the 18th and first half of the 19th centuries. Although the two story portion appeared late, early 20th century, the rear one and one-half story wing seemed earlier, and may indeed have been the original house or part of an earlier house.

As it stood in 1970, it was composed of two rooms on both floors with a single window and door to each room on the east side. Two dormers pierced the roof as did a central chimney. Typical of the early 19th century, especially noticeable in Caroline County, was the fact that the 4/4 sash in the dormers were set horizontally.


