The Nathan Parks House is the third house from the water on the east side of the Fairbank Road in the village of Fairbank on Tilghman Island, Talbot County, Maryland. This two-and-a-half story frame house faces west with the principal gable running on a north/south axis.

Originally built for Marianna Parks on Holland's Island, this house was disassembled and transported to Tilghman Island on the bug-eye "Spanish Chief" by her son, Captain Nathan Parks. The center hall frame house was reassembled in 1918, with the only change in plan being an enlarged entrance hall.

The Parks House is supported by a brick pier foundation, and is covered by an asphalt shingle roof. The exterior is covered in white vinyl siding.

The east (main) facade is a symmetrical elevation with a central door and flanking two-over-two sash windows with louvered shutters. The door has sidelights and the windows are shaded by striped awnings. A porch extends across the first story of the main facade with turned supports, decorative brackets, and a square post balustrade. The second floor is lit by three two-over-two sash windows with louvered shutters and striped awnings. A center bay cross gable with a pointed-arch window inset marks the attic story of the main facade. Two interior chimneys flank the central hall, and the open eave has exposed rafter feet.

The north gable end is lit by two two-over-two sash windows on the first and second floors. A square one-over-one sash window marks the attic story.

Stretching across the west (rear) elevation of the house is a one-story, enclosed addition with french doors. This addition was first added in the 1940s and then expanded in the 1980s. The second story is lit by three two-over-two sash windows.

The south gable end is lit by a pair of two-over-two sash windows on the first and second floors. An entrance door marks the south elevation of the rear addition. A square one-over-one sash window lights the attic story.


In 1918, Captain Nathan Parks transported his mother's house from Holland's Island to Tilghman Island on the bug-eye Spanish Chief. Although many houses were supposedly transported from Holland's Island to Tilghman around the turn of the century, the Nathan Parks House is the only one which is consistently referred to by Islanders as an extant result of a successful move. Despite its siding and fence enclosure, the character of the Parks' House has remained consistent with the simplicity of its original design.

The Nathan Parks House is one of a collection of two-story, three bay, frame dwellings which face the main street of Fairbank, and create an intimate village atmosphere.
