The Eddie Harrison house is located at the edge of Broad Cove in the village of Barneck on Tilghman Island, Talbot County, Maryland. The house faces north with the principal gable oriented on an east/west axis.

Built between 1890-1900, this two-and-a-half story frame house is clad in weatherboard, and roofed with asphalt shingles. The house is a side hall single pile plan supported by a brick pier foundation.

The three bay north (main) facade has two-over-two sash windows and a door as the eastern bay. The second floor is lit by three two-over-two sash windows. The windows have wide surrounds and peaked crown mouldings. A one-story shed roof porch extends the full width of the first floor.

There are no windows on the east elevation. This gable end is supported by two decorative brackets, and trimmed with modest bargeboards. An interior chimney rises above the east end.

The three bay south elevation is lit by a pair of two-over-two sash windows and a door serves as the eastern bay. The second floor has three two-over-two sash windows and the open eave has exposed rafter feet.

The west gable end has one door on the first floor as the northern bay. This door formerly connected the house to a summer kitchen which was removed in the 1980s when bulkheading was added to the property.

The interior was not seen.


