Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The W.H.Cummings house is located on the west side of Route 33, four lots south of Bayshore Drive, in the village of Tilghman, Tilghman Island, Talbot County, Maryland. This two-story, frame house faces east, with the principal gable oriented on a north/south axis.

Built around 1880-1890, the exterior of the W.H.Cummings house is clad in weatherboard, and the roof is covered in asphalt shingles. The low brick pier foundation has been converted into a full masonry foundation.

The east (main) facade has a modern, full width addition across the first story which is covered in weatherboard and has a central door flanked by storm windows. The second story is lit by three six-over-six sash windows with narrow surrounds and green louvered shutters. This building has green pilaster cornerboards.

The north elevation has cornice returns and one six-over-six sash window as the eastern bay of the first story. An interior brick chimney stack rises above this north gable end.

The west elevation has a central, two-story, single bay, projection which ends in a gable with cornice returns. The north side of this wing has one six-over-six sash window with narrow trim and the shadow of a former doorway on the first floor. There are two six-over-three sash windows with wide surrounds on the second floor. The south side of this wing has two six-over-three sash windows with wide surrounds on the second floor, and a one-story, modern shed addition on the first floor. A one-story shed addition on the first floor of this wing's west end has six-over-six sash windows and a set of double doors. The central bay of the three bay south elevation is flanked by six-over-six sash windows on the first and second floors of the northern and southern bays.

The south gable end of the primary wing has one six-over-six sash window with a narrow surround as the eastern bay of both the first and second floors, and one six-over-six sash window with a wide surround as the western bay of the first floor. An interior chimney pierces the roof of this elevation which has shallow cornice returns.



W.H.Cummings built this house in the late 1800s. His son, Reverend Wade H. Cummings, purchased this house from his father in 1907. The color scheme of this white house with deep green trim is typical of the older buildings on Tilghman Island.

The W.H.Cummings house has been enlarged over the years, but its relationship to the main street of Tilghman has remained essentially the same. The Cummings house is one of a collection of two-story, frame houses on Tilghman Island with a straightforward plan and delicate exterior detail.
