Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The Ben Harrison house is located on the southeast corner of Wharf Road and Route 33 in the village of Tilghman on Tilghman Island, Talbot County, Maryland. This house, which is one of the Island's six remaining "W" facade houses, is really an ell with a central, two-story, projecting bay. The house faces northwest with the north gable end of the ell facing Wharf Road, and the west gable end facing Route 33.

The two-and-a-half story, frame house is sheathed in asbestos shingles, and the roof is covered in asphalt shingles. The house is supported by a low, brick pier foundation.

The northwest (main) facade of the house has a central, three-sided, projecting bay crowned by a cross gable with a pointed-arch window inset. The four panel entrance door is at the center of this bay. The door has sidelights, a two light transom, and a one-over-one sash window on either side. The central bay is flanked by a pair of two-over-two sash windows. The first floor of this facade is enclosed by a screen porch with turned posts and a green awning. The second floor of the porch is enclosed by a miniature wrought iron railing. The arrangement of the second floor is identical to that of the first except that the central door of the projecting bay has been replaced by a smaller glass door.

The north elevation has cornice returns and a pair of two-over-two sash windows on both the first and second floors. A brick chimney rises above the north gable end.

The west elevation has five bays and a sharply peaked cross gable with a pointed-arch window inset over the central bay. There are five two-over-two sash windows on the second floor. The first floor is almost completely covered by an enclosed, flat-roofed, 1966 addition with sliding doors and modern windows.

The south elevation has four bays of two-over-two sash windows on the first and second floors. Above the eastern two bays of this elevation is a gable end roof with cornice returns, and an interior brick chimney stack.

Benjamin T. Harrison built this house in the late 1800s. He was a local magistrate, and one resident of the Island remembered when court was held at this house in the evenings in the 1920s. Roy Harrison bought this house from his father in 1952.


The Ben Harrison house is one of six remaining "W" houses on Tilghman Island. A second house of this type sat directly across Wharf road from the Ben Harrison house until a fire in the mid-1980s destroyed it. The Harrison house is a distinctive local house type, yet it differs slightly from the five other houses of this "W" configuration on the Island. Both the Harrison house and "the Gables", also on Wharf Road, have a triangular central cross gable rather than one which breaks back towards the eaves of the projecting wings. These two houses seem heavier and somehow larger than the others of this type.

Ben Harrison house description continued.

The west elevation has cornice returns and one two-over-two sash window on the first floor over one two-over-two sash window on the second floor.

The interior was not seen.
