The Wharf Road bungalow is located on the south side of Wharf Road in the village of Tilghman on Tilghman Island, Talbot County, MD. This one-and-a-half story, frame house faces north, with the principal gable oriented on an east/west axis.

Built between 1930-1940, the exterior of the Wharf Road bungalow is clad in yellow weatherboard and the low pitched roof is covered in asphalt shingles. The foundation is higher than that of most homes on Tilghman and is made of rusticated stone.

The north (main) facade of this three bay structure has a central door flanked by eight-over-one sash windows. A full width porch stretches across the first floor supported by rusticated stone piers with a square post balustrade. There is a single gable roof dormer with a central, single pane window inset flanked by eight-over-one sash windows.

The east elevation has three pairs of eight-over-one sash windows on the first story and a single one-over-one sash window in the upper half story.

The south (rear) elevation has a central door with two four-light casement windows as the western bay and one eight-over-one sash window as the eastern bay. There is an interior brick chimney in the center of the south roof slope.

The west elevation is identical to the east elevation with three pairs of eight-over-one windows on the first floor and one one-over-one sash window in the upper half story.

The interior was not seen.



The Wharf Road bungalow is one of the most recent houses built on Wharf Road in the village of Tilghman. Built between 1930-1940, it is representative of the many bungalows which line the main road and side streets of Tilghman Island. Some of these craftsmen bungalows, like the Murphy home in Fairbank, were acquired through mail-order catalogs. They seem to replace the two-story, single pile frame houses of the 1880s-1900s as the most common dwelling of Tilghman residents in the second quarter of the twentieth century.
