Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The Bayshore Cottage is located on the west side of a dirt road on the south side of Bayshore Drive. The house faces north with the principal gable oriented on an east/west axis.

Built between 1890-1910, this two-story, frame house is supported by a cement foundation and sheathed in white weatherboard with green trim. The roof is covered in asphalt shingles.

The north (main) facade has three bays with a central door flanked by two-over-two sash windows. There are two two-over-two sash windows on the second floor. A one-story, gable roofed addition is attached to the east end of this structure and has one two-over-two sash window on the north side. A second and more recent addition clad in aluminum siding and covered with a gable roof is connected to this first addition.

The east elevation is blind with an interior chimney stack piercing the gable roof of the main structure.

The south elevation is identical to the north with a central door flanked by two two-over-two sash windows on the first story, and a pair of two-over-two sash windows on the second story. There is a second door on the south elevation through the first addition.

The west elevation is blind.



Built between 1890-1910, this two-story, single pile frame structure is one of a collection of simple vernacular dwellings on the west side of Route 33 in the village of Tilghman. This building is in poor repair, but retains much of its original exterior fabric. It also has the distinctive green and white color scheme of so many Tilghman buildings. An almost identical house sits to the north of this structure on the same dirt road.
