DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

At the bend in Presqu'ile Road stands an interesting one and one-half story brick dwelling with two story frame addition on its northwest gable. The wing is of little value architecturally and will not be described.

The brick section has a central chimney rising from the 'A' roof. On the southwest side of the roof is a dormer, probably installed when the wing was added in order to light that room. Below the dormer, the facade of that half is relatively symmetrical, with central door and two windows with 6/6 sash. The other half has a single window which appears to have been originally a central door. On the south gable is a single window on each floor. The walls are laid in common bond brick without water table and are covered partly with whitewash, partly with stucco.

STATEMENT OF SIGNIFICANCE

This tenant house appears to have been built either by a small farmer or by one of the Lloyds as a tenant house. In either case, the building is of interest due to its early 19th century date and the similarity it has to the kitchen wings of several dwellings on the Eastern Shore. In plan it is identical to Lyford Landing, Caroline County as well as the wing on Choptank Farm east of Easton.
