Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The Tilghman Country Store is located on the northeast corner of Route 33 and Gibsontown Road in the village of Tilghman on Tilghman Island, Talbot County, MD. The structure faces south, with the principal gable oriented on a north/south axis.

Built in 1877, this one-story structure is clad in cedar shake shingles and weatherboard. The roof is covered in asphalt shingles, and the brick pier foundation is hidden from view.

The south (main) facade is a three bay gable end with a central door flanked by six-over-six sash windows. This facade is clad in cedar shake shingles and has cornice returns. There is a shed roof porch across the first floor supported by square posts which rest on a cement slab.

The west elevation is covered in cedar shake shingles and has one centrally placed six-over-six sash window. To the north of this earlier building is a two-story, gable end addition built in 1899. Across the first floor of the 1899 structure is an enclosed shed roof addition covered with wide weatherboard planks. This first floor addition has a central entrance door. Two two-over-two sash windows light the second story which is clad with fishscale shingles.

The north elevation has a one-story, shed roof addition which wraps around the east end of the building to the southern elevation of the 1899, two-story wing. The western end of this addition is clad in weatherboard and has one two-over-two sash window. The eastern end is clad in asbestos shingles and has one-over-one sash windows and double doors. The second floor is lit by three two-over-two sash windows.

The east elevation of the two-story wing is blind. The east elevation of the one-story 1887 structure has one window which is now boarded up.

The interior of the building has been completely reworked, but the present owners have old photographs displayed in the store which show its interior in the 1930s. Shipping crates which were broken up and used to cover ceiling beams are also visible above the modern ceiling tiles. The icebox at the rear of the store, although not original, came from the Faulkner

The Tilghman Country Store was first opened by John W. and Martha Gibson who purchased this property in 1885 and built the store in 1887. In 1889 the store was sold to Nannie and Oliver Cummings who kept it for ten years until 1899 when Edward N. Lomax purchased the store. Lomax turned the store to face Gibsontown Road and built a two-story living quarters on the rear.

In 1900 Mrs. James Nick Cummings rented the store for the sale of general merchandise and her husband acted as Postmaster in an area rented by the U.S. Government. Edward N. Lomax died in 1912 and the property was conveyed to Sarah Anna Cummings who kept the store until her death in 1927. Between 1933 and 1942 Oscar Sinclair rented the store from the owners, Walter B. and Goldie Cummings.

In 1942 Albert and Lois Sweitzer took over the Country Store and in 1956 the property was purchased by Camper and Gretchen Scharch. Ray and Katherine Kapisak bought the store in 1963 and operated it until 1970 when it was sold to William E. and Patricia Kennedy. In 1980 the store was owned by John Thomas and Kay B. Norwood. Today it is the property of Karl Grogan.

For over 100 years the Country Store has served the Tilghman population. This store is one of the few remnants of the "Central Market Place", a commercial area designated between Gibsontown and Mission Roads in 1900 in the hopes of organizing the village's rapid growth. The Country Store continues to be actively patronized and is a local landmark both because of its age and convenience.




