Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The Tilghman Pool Hall is located on the southwest corner of Coopertown Road and Route 33 in the village of Tilghman, Tilghman Island, Talbot County, MD. The store faces east with the principal gable oriented on an east/west axis.

Built around 1900, the exterior and roof of this one-story, frame structure is clad in asphalt shingles. It is supported by a very low brick pier foundation.

The east (main) facade is completely sheathed in plywood.

The northern elevation has three western bays of two-over-two sash windows. A four panel door separates these three bays from one two-over-two sash window at the eastern end of the building.

The west (rear) elevation has a central exterior cinderblock stove stack flanked on the south by one two-over-two sash window. This gable end has shallow cornice returns.

The south elevation has four western bays which project slightly to the south of the two eastern bays. This projecting section is lit by three two-over-two sash windows and one entrance door. An exterior brick stove stack sits at the east end of this projecting section. The two eastern bays consist of one two-over-two sash window and an entrance door.

The interior was not seen.


Prepare both a summary paragraph of significance and a general statement of history and support.

One local resident remembers this dilapidated building as the former Birmingham store. Another suggests that it was the home of Charlie Howeth's store. Many residents remember when this structure was operated as a pool hall.

If this is, in fact, the former Birmingham store, it was built in 1898 by Charles Lomax. Lewis and Ella Birmingham operated it until their death when it passed to their son Lewis M. In 1954 it was being operated by Melvin O. Birmingham's mother.

The Tilghman Pool Hall is in poor condition, but it remains one of a block of former commercial ventures including the neighboring McCarty Tavern and the still thriving McCarty Store.
