Distinguished by its large size and several unusual details, the property commonly known as "Old Point Comfort" provides significant architectural variety to North Morris Street when compared to the other houses and store buildings nearby. This two-part house was originally erected as a combination house and store. The private dwelling, obscured by trees, is set back from the street. The two-story side hall, three-bay house features a decorative turned post porch enriched with a sawn eave decoration and a rooftop balustrade. Projecting forward from the residence and dominating the property is a large two-and-a-half story gable-front section designed to house a commercial business. Distinctive to the first floor elevation is a side entrance flanked by diamond shaped windows framed by bulls-eye block surrounds. The entrance wall is recessed under an engaged porch supported by Tuscan columns. A bay window pierces the wall on the other side of the front door. While several combination dwelling/store structures were erected in Oxford during the late nineteenth century, only a small number retain their original architectural form.

The combination house and store structure was erected around the turn of the twentieth century on a lot that had been improved previously. The 1891 Sanborn Insurance map indicates an ell-shaped dwelling on the lot, but by 1896 when the next map was published the lot was vacant. By 1901 the outline of a structure conforming to the extant house and store was indicated at this site. During these years the property was held by Miss Annie L. Harrison, who purchased the property from Ormond Hammond, a trustee for

Samuel Stewart. She held title to the property from 1893 until the early 1920s when a court settlement forced its sale. The origin of its current name, "Old Point Comfort," is not certain.

The property known as "Old Point Comfort," formerly combining a house and store, is located at 218-218B North Morris Street in Oxford, Talbot County, Maryland. The two-and-a-half story main block faces west with the principal gable roof oriented on an east/west axis.

Dating around 1900, the two-and-a-half story ell-shaped main block contains a side hall/parlor dwelling on the south side and a large-gable front frame section on the north. The large gable-front frame structure was originally used as commercial space. Supported on a low brick foundation, the exterior is clad with a combination of original weatherboards and aluminum siding. The various gable roofs are covered with asphalt shingles.

The west (main) elevation is an uneven ell-shaped facade with the entrance wall of the domestic half recessed well back of the commercial front. The domestic front is defined by a side entrance and flanking two-over-two sash windows. A boldly molded and paneled door is framed by a large two-light transom and two-light sidelights, and the adjacent windows retain louvered shutters. Sheltering the first floor is a turned post porch embellished with sawn brackets and a rooftop balustrade. Three two-over-two sash windows light the second floor.

The west entrance wall of the commercial block is set back under an engaged porch supported by paired Tuscan columns supported on brick plinths. The porch columns rise to a mid-level cornice embellished with incised scroll decoration. The main entrance is located in the south bay and is distinguished by a pair of quirky diamond-shaped windows on the south side and a six-pane transom above. The window openings, set diamond point to diamond point, are framed by bulls-eye block surrounds. The opposite bay is marked by a three-sided bay window. A large single-pane window on the flat side is flanked by narrow single pane windows to each side. The knee wall of the bay is defined by a series of long rectangular panels, and the cornice is embellished with a saw-tooth shaped decoration. The corners of the first floor are embellished with decorative corner boards that have large decorative medallions. The second story is pierced by a series of three evenly spaced two-over-two sash windows flanked by louvered shutters. The expansive gable end above is covered with various bands of fishscale shingles with a large tripartite center window. The eaves are extended with returns at the base of the roof.

The north side of the commercial block is defined by an asymmetrical fenestration of two-over-two sash windows. Centered on the steeply pitched roof is a cross gable. A single flue brick stove chimney rises through the gable end.

The interior is divided into multiple apartments, and each space was not inspected. The commercial side of the building has a long narrow passage that extends the depth of the building. Centered halfway down the hall is a turn of the 20th century newel post with paneled sides, egg-and-dart panel moldings and a pyramidal cap carved with foliate forms. The high ceiling is covered with narrow tongue-and-groove beaded boards.
