The Thomas W. Blades house differs from most of the other late nineteenth-century houses that line North Morris Street. The two-story, three-bay frame dwelling was built directly on the street in the manner of an urban row house rather than with a common fifteen- to twenty-foot set back like other houses to each side. In addition the two-story facade was designed with a parapet front embellished with brackets and incised decoration rather than the more common hip or gable roof that covers other houses in Oxford. The parapet disguises a long sloping shed roof, which is also common to row house architecture. The Blades house, however, is not one of a dozen that distinguish this block. It is a single expression of a narrow row house architectural form, and therefore rare for the town of Oxford.

The Thomas W. Blades house was built at a time when prosperity had returned to this Tred Avon village. Estimated to date around 1883, the house was one of scores erected during the 1880s. Thomas W. Blades leased this lot from Philemon and Mary A. Willis in June 1883 and probably erected the house shortly thereafter. Although he and his wife Susanna sold the property five years later, it was purchased by Oswald Tilghman, who transferred it five months following his acquisition to Ella Francis Bratt for \$800. The house passed through numerous owners during the late nineteenth and early to mid twentieth century. In 1973 the house and lot were acquired by Norman and Charlanne Harrington, who financed a modern addition to the north side of the row house form. Set back from the main facade of the Victorian house, the modern wing was

designed in a streamlined yet compatible fashion. With its set back from the street and landscaping in front, the modern addition was clearly conceived as a new, and at the same time, integral part of the old house.

The Thomas W. Blades house is located at 208 North Morris Street in Oxford, Talbot County, Maryland. The two-story, three-bay frame house faces west.

Dating around 1883, the two-story, three-bay frame dwelling is supported on a low brick foundation, and the exterior is clad with a combination of German siding and plain weatherboards. The main block is covered with a long sloping shed roof. Attached to the south side of the late nineteenth-century house is story-and-a-half addition of modern design which is set back from the street.

The west (main) elevation is a three-bay facade with a side entrance and flanking two-over-two sash windows. Framing each window is a narrow beaded surround. The heavily molded front door is topped by a two-light transom, and the adjacent windows retain louvered shutters. Sheltering the first floor is a chamfered post porch embellished with sawn corner brackets and a sawn baluster handrail. Covering the shallow pitched hip roof is a layer of seamed tin. The second floor is defined by three evenly spaced two-over-two sash windows flanked with louvered shutters. The top of the front wall is finished with a bracketed parapet that disguises the long shed roof behind. A series of eave brackets are interspersed between decorative cornice panels incised with a repeating floral design. The cornice is trimmed with a crown molding.

The north side is marked by an asymmetrical placement of narrow two-over-two sash windows, and a two-story wing extends to the rear. Attached to the south side of the rear wing is a story-and-a-half addition that follows a modern design. The exterior of the addition is sheathed with vertical board siding.

The interior of the late nineteenth-century house has been extensively reworked with the turned baluster staircase as the only surviving original feature. A narrow turned newel post and a series of turned balusters support a molded handrail. The balance of the interior has been renewed with plain board door surrounds and hollow core doors.

The modern addition has a sunken living room behind a narrow paved vestibule. The ceiling is sloped and is open to a second floor space incorporated in the rear wing.








