The Charles E. Leonard house is one of the more unusual late nineteenth-century dwellings standing along North Morris Street. Its diminutive size and variety of architectural detail make the house a distinctive architectural element in the streetscape. The asymmetrically planned house has an uneven front elevation with a recessed entrance bay sheltered by a chamfered post porch embellished with sawn corner brackets. Decorative brackets also embellish the cornice returns of the main roof, and delicate wooden finials rise from the peak of several gables. The interior retains a large portion of its late nineteenth-century woodwork including a turned baluster stair railing and Victorian mantels on the first floor.

Chain of title research for this lot traces its ownership back to Charles E. Leonard, who purchased this lot from Samuel Stewart in 1880. As indicated on the 1877 town map the lot was unimproved. Charles E. Leonard died eight years later, and in his will he passed the Oxford house and lot to his wife Nellie G. Leonard, who apparently remarried and moved to Baltimore. Under the name of Nellie G. Graham of Baltimore City, she sold the property to Howard W. Newnam in August 1902 for \$600. The first indication of a house on this lot is provided by the Sanborn Insurance Company map published in 1891.

The next long-term owner were John E. and Sarah Elizabeth Stevens, who acquired the property in 1915. Stevens family tenure continued until 1955.

The Charles E. Leonard house is located at 206 North Morris Street in the center of Oxford, Talbot County, Maryland. The two-and-a-half story, asymmetrically planned frame house faces west with the principal gable roof oriented on an east/west axis.

Estimated to date around 1880, the two-and-a-half story frame house follows a tee-plan with a story-and-a-half kitchen wing to the rear. Supported on a low brick pier foundation, the exterior is clad with vinyl siding, and the steeply pitched roof is covered with asphalt shingles.

The west (main) elevation is an asymmetrical facade with a projecting gable end wall juxtaposed against a recessed side entrance that pierces the south leg of the tee-shaped main block. A chamfered post porch decorated with sawn brackets shelters the first floor. Piercing the first floor of the gable end wall is a paired single-pane sash window opening flanked by louvered shutters. The front entrance is distinguished by a two-light transom and three-light sidelights. The front door is partially glazed with beveled glass above the lock rail. Raised panels framed by ogee moldings distinguish the door below the lock rail. Piercing the second floor of the gable-front wall is a two-over-two sash window flanked by louvered shutters. Lighting the attic is a round arched window. The edge of the roof is finished with an extended eave trimmed with decorative brackets under the returns. Fixed atop the peak of the roof is a wooden finial. A narrow brick stove chimney rises through the center of the house. A second wood finial is fixed to the peak of the south gable end.

Attached to the back of the house is a story-and-a-half kitchen wing that extends eastward with a long shed roofed addition covered by a seamed tin roof. Six-over-six sash windows light the rear wing and the edge of the roof is finished with a flush eave and plain bargeboard. Attached to the south side of the house is a single story enclosed porch.

The interior retains a large portion of its late nineteenth-century woodwork. Remaining in the front hall is a Victorian staircase with a boldly turned newel post, a molded handrail, turned balusters, and a scroll decorated stringer. A light-weight beaded board door opens into the stair closet. Four-panel doors are framed by beaded edge surrounds. Victorian mantels remain on the first floor.




