DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

46-48 East Street, Hagerstown is a large double brick residential dwelling. The notable feature is the bowed front which culminates in a peaked, conical roof (one on each side); with the addition of dormers clustered on these peaked roofs, each half of the house is similar to 139 North Potomac Street and both buildings were undoubtedly built at the same time and perhaps by the same speculative builder.

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

46-48 East Street is a late 19th century residential dwelling, probably built speculatively. However, the use of the bowed fronts and especially the three peaked dormers on the concial peaked roofs give this house a great deal of visual interest and helps to break up the somewhat long, unbroken block.




