DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

135-137 North Locust Street, a continuation of the row 111-123 and 125-127 North Locust, is a 2 storey, double brick house. Smaller than its neighbor 126-127, this house is also not cheek-by-jowl with its neighbors, there is a garden between it and 125-127. Comprised of two three bay urban dwellings set side by side (i.e. doorways are next to each other), the windows still retain their 6/6 mullions and have flat wood lintels; all have shutters. Interestingly, 135 has an internal end chimney as do the others on this block, while 137 has an external chimney on the opposite end wall. There is a central ell on the rear.
