The Moss Building is a nineteenth century, brick structure which probably was erected as a dwelling. It has the basic symmetrical form with double-end chimneys associated with the classical styles but has Victorian segmental arch windows, incised decoration and cornice. Although extensively altered in recent years, the upper levels of the two and a half stories high building appear to retain much of the original features.

<p>The Moss Building stands at 46-48 South Potomac Street in Hagerstown, Washington County, and is located on the east side of the street in the southern half of the block formed by Public Square and Antietam Street.</p> <p>The building is a nineteenth century, two and a half stories high painted brick structure which has a symmetrical facade (west side), internal double-end chimneys, and parapets along the end walls. Presently used for commercial purposes, the building sits tight to the sidewalk and the building to the south and has a new (1975) brick facade with a mansard roof on the first floor and a twentieth century three-window dormer on the roof above the south two windows of the facade.</p> <p>The upper level of the facade has five symmetrically arranged segmental arch windows and a broad cornice with two end brackets. The windows have rectangular, double-hung, wooden sashes with modern three-over-three lights. The arch panels above the windows have incised scroll decoration.</p> <p><i>Upper level bricks of street or west facade sandblasted in Sept 1976</i></p>


