DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

128 South Potomac Street is a 2½ storey brick late Georgian style style house. Not unlike other houses in downtown Hagerstown of the period (141 South Potomac, 26 East Antietam, etc.), this example has suffered some alteration in that side windows have been filled in and front windows altered with 2/2 mullions, etc., plus a box window affair has been extended over the front door at second storey level. There are three dormers with 9/6 windows on the front slope of the roof.

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

128 South Potomac Street has been somewhat changed, but basically it is still an early 19th century urban dwelling of a type once common in Hagerstown (66-68 West Washington Street, for example); it has three 'Philadelphia' dormers which would tend to place it around 1810 [?]. Its age alone makes it worthy of restoration and preservation, however it doubly important, being opposite 141 South Potomac, a house of similar style.


