DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The McCrory Building is located at 50-56 West Washington Street in Hagerstown, Washington County, and stands on the north side of the street near the center of the block formed by Public Square and Jonathan Street.

The building is a mid-late twentieth century masonry commercial structure of two stories in height. The front (south side) has a run of large display windows at the street level and a row of small squarish windows with a long project above on the second floor. The exterior of the facade is covered with polished panels. The interior was rebuilt in 1975 following a fire.
