DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This house is located west of College Road, about 1/4 mile north of Md. Route 68, near St. James in Washington County. It is situated in an area of level ground and faces south.

The structure is a two-story, three-bay brick dwelling with white trim. A four-bay el or wing extends to the rear or north.

The walls are set on low limestone foundations of coursed brick. Flemish bond brickwork is employed in the front elevation while other walls display common bonding with generally five courses of stretchers between rows of header bricks. Decorative brickwork includes flat arches over openings at all elevations.

Windows and doors appear to be spaced evenly in the walls. No openings are present in the east or west walls of the front section, except for small windows at the attic level. The windows of all elevations contain six-over-six pane double-hung sashes held within narrow frames with rounded surfaces.

The main entrance is located in the east bay of the front or south elevation. The doorway is rather elaborate in appearance, showing Greek Revival influence. A broad transom and sidelights above decorative pnaels surround the double three-panel doors, which are flanked by plain colonnettes. The jambs are finished with decorative panels. Other entrances, located in the el are much simpler including only a transom above the door.

A pedimented entrance porch supported by chamfered square posts with brackets is present at the main entrance. A one-story, three-bay lean-to porch is located at the west elevation of the el. The east side includes a two-story porch extending the length of the el which is framed under the main roof span.

The roof is covered with corrugated sheet metal and terminates at the gables with a broad barge board set against the end walls of the house. The eaves boxing is finished with several courses of plain molding. Brick chimneys rise from inside each gable end.

The house is in good condition and stands on a tract containing 165.50 acres.

**STATEMENT OF SIGNIFICANCE**

The area of significance of this house is its architecture. A three-bay, end-door house, it is a well maintained example of a major architectural group in Washington County and the Cumberland Valley. Built in the half plan version of the five-bay, center-door Georgian-form farmhouse, this dwelling, showing also Greek Revival influence, is very typical of a number of farm and townhouses in the area. Its exterior appearance would suggest that it probably dates from the middle third of the 19th century.


