<p>This house is located a short distance east of Maryland Route 66 at its junction with the Chewsville Road about three miles south of Smithsburg in Washington County. It is situated on an area of level ground and faces west.</p> <p>The structure is a two-bay, one-and-a-half story frame dwelling covered with artificial brick siding. It is set on low fieldstone foundations.</p> <p>Openings are spaced at random in the walls. Most windows contain two-over-two pane double-hung sashes with plain trim.</p> <p>The roof is covered with sheet metal and extends beyond the end walls of the house.</p> <p>The house is in good condition and is located on a farm containing 146.77 acres. The main farm house on the property (WA-I-047) is located along Route 66.</p>
