DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>"Hidden Hill" is located about 1/4 mile south of Md. Route 64 at 1400 Indian Lane in Washington County, Md. It is situated on a gentle slope above the Antietam Creek and faces northwest or toward the Creek.</p> <p>The structure is a two-story, five-bay brick dwelling painted white with black trim. A two-bay, one-story brick section extends to the rear.</p> <p>The walls are set on low fieldstone foundations. Flemish bonding is employed in the front or nothwest wall as well as the end walls of the house. The rear or southeast wall displays common bonding.</p> <p>Decorative work associated with the walls includes flat brick arches over the windows.</p> <p>Windows appear to have been spaced evenly at the front and side elevations. Those which appear to retain early or original frames display moderately wide wooden members trimmed with quarter round molding. Other windows show narrower frames. All contain nine-over-six light double-hung sashes. Lower story windows are flanked by paneled shutters while those at the second level are flanked with modern louvered shutters.</p> <p>The main entrance is located in the central bay of the front elevation. The door is flanked by fluted pilasters set in a modified entablature. Over the door is a semi-circular fan light with webbed ray muntins. A modern neo-colonial entrance porch is present at the front elevation. Other entrances are located in the broad wall of the one-story section. These entrances are quite simple in appearance and do not appear to retain their original framing. An arched, partially subterranean opening enters into the basement.</p> <p>The roof which appears relatively modern, extends beyond the end walls of the house. Dentil trim finishes the cornice. Brick chimneys rise from inside each gable end.</p> <p>The house is in excellent condition and is located on a tract containing 3.2 acres.</p>

STATEMENT OF SIGNIFICANCE

The area of significance of this house is its architecture. Constructed of brick in the five-bay center hall plan, the house is an excellent and well maintained example of a Georgian-inspired dwelling of the Cumberland Valley. Such dwellings are prominent in the area with examples dating from the late 18th through most of the 19th century.

The exact building date of this house is not known. Documentary evidence as well as the appearance of the house suggests that it was standing when Christian Newcomer sold the property containing about 103 acres in 1821. Newcomer had acquired 500 acres from the estate of Martin Rohrer in 1807.

Most renovations to the house took place during the ownership of Jack H. and Louise F. Beachley.

According to local tradition, a fording place of the Antietam was located approximately in front of the house. An old mill, known as "Martin's Mill" is said to have been located near this site. Charles Varle's 1808 map of Washington County shows a mill at this approximate location.






