DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The portion of "Rock Hall" known as "The Ground Farm" is located about one-half mile north of Maryland Route 64 off Belvedere Road, on the east bank of the Antietam Creek. It is situated on an area of level ground and faces southwest.

The structure is a two-story, three-bay brick dwelling painted white with dark green trim. A two-story, four-bay el with a shed roof extends to the rear. The house is set on foundations of roughly coursed local fieldstones. The bricks are laid in flemish bond at the front elevation and in common bond at the side and rear walls. Decorative trim associated with the brickwork includes flat arches over window and door openings and brick cornice trim at the eaves.

Windows appear to be spaced evenly in the front section of the house. Nine-over-six light sashes are held within narrow frames in all windows except the south elevation of the el where six-over-six light sashes are present.

The main entrance was located in southernmost bay of the front elevation. The doorway has since been made inoperable. The height of the entranceway would suggest that a transom was present. Other entrances are located in all elevations of the el.

The roof is covered with sheet metal and terminates with a barge set directly against the end walls. A large brick flue rises from inside the northwest gable wall. A newer brick chimney rises from the end of the el.

Also on the property is a modern clubhouse and the remains of an old field stone springhouse.

The house is in excellent condition and stands on a tract containing 138 acres. The property is at present used by the North American Rod and Gun Club.

STATEMENT OF SIGNIFICANCE

The area of significance of this house is its architecture. Constructed of brick in the three-bay plan with an end entrance which is sometimes termed "half Georgian," it represents a major building type in Western Maryland and the Cumberland Valley. Most brick structures similar to this house date roughly from the second quarter of the 19th century.

This property is part of the original Rock Hall tract which contained 302-3/4 acres and was surveyed for William Shanyfield on January 14, 1807. According to Washington County Land Patent Records (Liber Z, Folio 323), Shanyfield received a warrant to resurvey into one tract various parcels lying contiguous. The parcels included parts of "Sheep's Land," "Littleworth," "Downey's Lott," "Locust Bottom" and five pieces of vacancy.

Upon William Shanyfield's death in 1813, Rock Hall was split with approximately 145 acres bequeathed to William's son, Andrew. In 1827, some time after Andrew's death, his real estate was sold. In 1830, this portion of "Rock Hall" was purchased by Joseph Ground. It remained in the Ground family until about 1920. The remainder of the Rock Hall tract is discussed in form WA-I-107.


