DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This house is located north of the Chewsville Road, about one-half mile west of Maryland Route 66 in Washington County, Md. It is situated on level terrain and faces southwest.

The structure is a three-bay, two-story frame dwelling covered with artificial brick siding and trimmed with white. A three-bay one-and-a-half story stone and frame el extends to the rear or northeast.

The walls are set on low stone foundations. Those walls which are constructed of stone have been covered with a layer of stucco or rough cast which has been scored with vertical and horizontal lines to achieve the appearance of ashlar block. Other walls are without decorative trim.

Windows are placed evenly in the front section of the house. They contain modern single-pane sashes held within narrow frames. A projecting gable at the front elevation holds a late Victorian period palladian-style window. Windows of the stone section hold six-over-six pane sashes held within narrow frames with mitered corners.

The main entrance is located in the center bay of the front elevation. The entranceway is simple in appearance with a narrow transom present over the door.

A three-bay, one story entrance porch extends across the first story openings.

The roof is covered with asphalt shingles and extends for several inches beyond the end walls. Small brick chimneys with several courses of corbels at their tops are present inside each gable end. A similar interior brick chimney rises from inside the el.

The house is in good condition and stands on a tract containing 48.25 acres.

A short distance north of the house is a stone spring house with a broad overhanging roof at its east elevation. Also nearby is a small stone and frame bank barn.


