DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This house is located at 522 Antietam Drive, Hagerstown, Washington County, Maryland. It is situated on the east side of the road and faces west.

The structure is a one-and-a-half story, three-bay log dwelling sheathed with aluminum siding. The construction of the walls, which are set on low roughly coursed fieldstone foundations, is concealed by the siding.

The windows are modern in appearance with single-pane, double-hung sashes. They are flanked by louvered shutters. The main entrance is located in the north bay of the west elevation and is very plain in appearance.

The roof is covered with sheet metal and extends for several inches beyond the end walls of the house. A small brick interior chimney is located near the center of the roof ridge. A modern brick exterior chimney is present at the south wall.

The house is in excellent condition and stands on an 80' X 280' lot.

STATEMENT OF SIGNIFICANCE

The area of significance of this house is its architecture. Although its original appearance has been altered, it is an example of a log dwelling which probably dates from after 1850. Thus, it reflects the persistence of an early vernacular building method well into the 19th century. According to local historians, this house and several others similar to it were built as company-owned houses by the paper mill which operated at Security from about 1865 to 1929.

The village of Security is also known as Bissel and as Fiddlersburg, a name which is said to have originated from a number of older men, who lived in the village during the late 19th century and who played their fiddles on summer evenings.

Several dated examples of Washington County's 18th century stone dwellings are located in Security.




