DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>Colonial Manor Farm is located about one-half mile north of Old Forge Road, east of Hagerstown. The house is situated on a gentle rise of ground west of Herman Myers Road and faces east.</p> <p>The structure is a two story, six bay dwelling constructed of local field-stone covered with a layer of stucco or rough cast. The section of the house comprising the northern bays of the front elevation has a recessed double porch included under the main roof span. There is no decorative work associated with the exterior walls.</p> <p>Windows of the south section of the front elevation appear to be spaced evenly in the wall, while other elevations show random window placement. A window is set in the north wall of the porch, a characteristic of many houses in the area with recessed double porches. All windows have six over six pane double hung sashes held within narrow frames finished with a bead. Many windows are flanked by pairs of louvered shutters.</p> <p>The main entrance is located in the second bay from the south end of the front elevation. It is framed similarly to the windows and includes a transom, divided into four triangular panes. The door is trimmed with three pairs of vertically placed panels. Another entrance in the front elevation with a similar transom is centered under the double porch.</p> <p>A one bay flat roofed entrance porch is present at the front elevation. All porch railings have a pattern of diagonal and vertical balusters.</p> <p>Just north of the house is a subterranean vaulted root cellar made of stone. This structure is entered through a latticed door. Also on the property is a large frame bank barn. In a field north of the buildings are several tombstones which appear to have been part of a nineteenth century private cemetery. Those stones which could be read were inscribed with the surname Lekron. Most of the death dates occurred between 1820 and 1825.</p> <p>The buildings are in good to excellent condition.</p>

**STATEMENT OF SIGNIFICANCE**

The Colonial Manor Farm is significant for its architecture. The cemetery on the property is also important for the record it provides of early residents of the vicinity.

The house is an example of a major architectural group in Washington County. Such structures are usually five to seven bays in length with a portion of the front elevation recessed behind a double porch which is included under the main roof span. Many buildings of this type date from the middle third of the nineteenth century.

The property was owned by Herman Myers from 1929 to 1942. Prior to 1929, it was in the Itneyer family, having been purchased by Jonas Itneyer from Doctor William Ragan in 1875. Thomas Taggart's 1859 map of Washington County shows the property under the ownership of C. Spessard.
