This farm, known as the Strite Homestead, is significant for its architecture and for its contribution to the history of a local family. The house would appear to have been built in at least two sections with the western portion of the structure being an addition. The earlier section, five bays in length with a center door follows a prominent house plan in Washington County with the exception of the absence of a window above the door which is the usual implementation of the plan. The house is similar to other structures in the County which were built during the second quarter of the 19th century.

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>This farm complex is located at the end of a private lane east of the Leitersburg-State Line Road and north of Strite Road in the Leitersburg vicinity of Washington County, Maryland. The house is situated on an area of level ground and faces south.</p> <p>The dwelling is a two story, eight bay brick structure set on low field-stone foundations. A vertical seam in the masonry divides the house between the third and fourth bays from its west end. East of the seam, the facade walls display Flemish bond brickwork. West of the seam and at the end walls common bonding is used with, generally, seven courses of stretchers between header rows. A one story, one bay brick out kitchen is attached to the north wall of the west end of the main structure.</p> <p>Openings are spaced symmetrically in each section of the front elevation. High flat arches are present over first story windows in the front elevation. Lower flat arches top the windows of the west end wall and at the first story of the west section. Openings at the second story level of the front elevation are topped with wide wooden lintels. Two over two pane sashes are held within narrow frames some of which have a beaded inner edge while other frames have rounded surfaces. Most windows are flanked with louvered shutters.</p> <p>Entrances are located in the second and sixth bays from the west end of the front elevation. They are located centrally in each of the two adjoining sections. They display framing similar to the windows and include transoms. Each entrance is sheltered by a small porch.</p> <p>The roof is covered with corrugated sheet metal and extends beyond the end walls. A large chimney extends from the south slope of the roof just below the ridge.</p> <p>The house appears to be in good to excellent condition and is located on a farm containing 100.66 acres. A large frame bank barn and other buildings related to agricultural use are located northwest of the house.</p>

STATEMENT OF SIGNIFICANCE			
<p>This farm, known as the Strite Homestead, is significant for its architecture and for its contribution to the history of a local family.</p> <p>The house would appear to have been built in at least two sections with the western portion of the structure being an addition. The earlier section, five bays in length with a center door follows a prominent house plan in Washington County with the exception of the absence of a window above the door which is the usual implementation of the plan. The house is similar to other structures in the County which were built during the second quarter of the 19th century. In his will made November 5, 1857, Joseph Strite, then owner of this property, directed that "my executors build an addition to the dwelling house which I now occupy if not previously built by me for the use of my beloved wife, Elizabeth. Said house shall be thirty feet in front and thirty feet back to the arched cellar which shall be for the use of said house. Said house shall be built of brick, two stories high and to be laid off with two rooms and a kitchen on the first floor and three rooms on the second floor." (Will Liber E, Folio 416). It is supposed that the house described in the will is the addition or western portion of the present structure.</p> <p>The property, part of the land grants "Rich Barrens" and "Dry Spring" was in the Strite family from April 11, 1797 when John Strite purchased land from Henry Snell.</p>


