Description of Property and Eligibility Determination: *(Use continuation sheet if necessary and attach map and photo)*

Built in 1898, this 2 1/2 story, brick (painted white) multi-gabled single family residence has a 2 story round tower with finial and slate patterned shingles on east side of house. There is a 1 story front porch with double wood 2-paneled entrance door. The windows are one over one configuration and have segmental arched windows, patterned shingled side gabled roof and dentils under the cornice. A rough cut rubble irregular coursed stone retaining wall runs along the front of property. A frame garage is located on the east side of the property. (See attached Maryland Historical Trust (MHT) Inventory Form).

The Eby house retains sufficient integrity to illustrate a late nineteenth century free classic Queen Anne style house along the National Road in Huyett. The house meets criteria A and C and is recommended eligible for the National Register of Historic Places.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is located on the north side of U.S. Route 40 just east of Huyetts Crossroads, west of Hagerstown in Washington County, Maryland. It faces south.

The structure is a two story, three bay brick dwelling dating from Ca. 1900. It reflects late Victorian period features, particularly of the Queen Anne style. It is an irregularly shaped building having a projecting gable at the west end of the front elevation and a round tower at the east corner. The building rests on low stone foundations. The bricks are laid on all stretcher bond at the main portion of the house with header bricks forming the tower. Segmental arches are present above all original windows in the brick section. The west bay of the front elevation is topped with a steeply pitched frame gable, its apex filled with a wooden sunburst design. A frame addition has been attached to the rear of the building.

Windows are not arranged symmetrically in the walls. They have narrow casings which hold single pane, double hung sashes. Windows in the front elevation are quite large. Most are flanked with pairs of louvered shutters. Pairs of double arched windows light the attic and a double set of windows is also present in the gable dormer.

The main entrance is located in the central bay of the front elevation. The door is treated similarly to the windows, having a broad segmental arch above a large rectangular transom. Hung from the casing are double doors with glass panes.

Part of the roof is sheathed with modern asphalt shingles while the conical roof of the turret has pressed tin shingles terminating at the peak with a metal rod. Decorative metal work trims the roof ridge. The roof extends beyond the end walls of the house and small scroll cut wooden brackets finish the eaves at the front elevation.

A one story porch extends along part of the front elevation and the west wall. It is supported by turned posts. A modern porch is attached to the east elevation.

A stone retaining wall divides the yard from the edge of the highway.

The house appears to be in excellent condition and stands on a tract containing 19.71 acres.


