DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This farm complex is located on the south side of Oak Ridge Drive just east of the Downsville Pike, Maryland route 632 south of Hagerstown in Washington County, Maryland. It is situated on an area of level ground and faces east.

The house is a two story five bay brick structure resting on low fieldstone foundations. A one story, three bay wing also of brick extends to the rear. The front or east elevation of the house displays all stretcher bond brickwork while the side and rear walls have American bond. Flat arches of brick are present above the windows and doors.

Openings appear to be aligned with each other in the walls. Windows have narrow frames finished with a bead at the inside edge and hold six over six pane double hung sashes. Shutter dogs remain in the walls of the house and pintles are set into the window frames indicating that shutters were present at one time. Two windows at each of the main stories are located in the end walls and full six over six windows are present at the attic level, centered in the gables at the north and south elevations.

The main entrance is located in the center bay of the front elevation and includes a four light transom above an eight panel door with matching paneled jambs. A one bay flat roofed entrance porch which dates from the 20th century shelters the front door. Evidence remains in the masonry of a wider porch, also one story in height which covered the center and second bays from the south end of the front elevation. Alterations to the masonry indicate that the window at the second bay from the south end was at one time a door.

The roof is covered with sheet tin attached in the standing seam manner and terminates with beaded barge boards set directly against the end walls. Large double chimney stacks linked by a parapet are located inside the end walls. Several bands of molding finish the eaves.

South of the house is a large frame bank barn, also facing east. The property, on a large farm, now includes 2.195 acres. The buildings appear to be in excellent condition.

STATEMENT OF SIGNIFICANCE

This farmstead consists of a brick dwelling which appears to date from the early part of the third quarter of the 19th century and a large frame bank barn. Characteristic of this period of 19th century construction in Washington County are the large double chimney stacks, the use of all stretcher brick bond at the front elevation as well as the type of window and door treatment described here.

The farm of which these buildings were at one time a part was in the Roney and related families since 1909. Prior to that time it was held by Cornelius Stouffer and Hiram D. Stouffer respectively, sons of John W. Stouffer who owned the farm until his death in 1877. Presumably it was John W. Stouffer who built the house.

The farm included parts of the land grants "Hazel Bottom," "Good Luck" and "Establishment."


