DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is located on the north side of Doub Road, just east of the Penn Central Railroad tracks, east of Williamsport in Washington County, Maryland. It is situated on an area of level ground and faces north.

The building is a two story, three bay stone structure with its west gable end facing Doub Road. The south elevation is two bays in length, its more westerly bay within a recessed double porch included under the main roof span. The double porch has since been enclosed and sheathed with late 19th century German siding. A one story shed roofed porch extends around the north and west walls. It is supported by turned posts and rests on a concrete slab.

The walls are constructed of roughly coursed native limestone with somewhat finer workmanship being used at the front elevation. Many of the stones in the walls are relatively large with little uniformity of size and shape shown. Large stone lintels are present over the first story openings at the front elevation.

Windows have beaded frames which hold six over six pane double hung sashes. No evidence remains of the windows having had shutters. Openings at the front elevation are offset slightly toward the west wall. The main entrance is located in the middle bay of the front elevation. The door has four panels in which the upper two sections have been replaced with glass. It is hung beneath a three light transom. A similar door and transom is located in the west end wall.

The roof is sheathed with sheet metal and extends beyond the end walls of the house. A brick chimney with a corbel at its top is located inside the west end wall while a smaller, plain brick flue is located inside the east end wall. Plain boxing finishes the eaves.

Various sheds and outbuildings are located near the house. The structures appear to be in good condition on a property which contains 8.27 acres.

STATEMENT OF SIGNIFICANCE

This house and its related outbuildings form a 19th century rural complex typifying Washington County's vernacular architecture. The house would appear to date from the mid or the third quarter of the 19th century as suggested by the type of masonry in the walls, woodwork trim and the door and window treatment. Land records indicate that this property was lot # 2 in the partitioning of the real estate of William Bowers which occurred after his death. According to the land records Bowers' property was divided into lots on February 16, 1976 and, parceled out among his children. This tract is part of a large land grant called "Conococheague Manor" which was held by Lord Baltimore until about 1767. This proprietary manor located near Williamsport included nearly 11,000 acres.


