The frame house is a one-story, three-bay by two-bay structure on a concrete foundation. It has a gable roof covered in asphalt shingles. The main facade has a gable over projection the southernmost bay. There is a one bay wing on the south gable end. The house appears to have been constructed in the mid-20th century.

The frame house is located on the east side of Rt. 65, .25 miles south of I-70. It is situated in a cluster of buildings dating from the mid-20th century to the present time. This house was built in the 1940-50s.

The walls of the structure are covered in a modern white siding. The main facade has a central entrance with a one-bay entrance porch. The northernmost bay has a six-over-one sash window. The southernmost bay has a two part window. The wing has a six-over-one sash window on the main facade. The north gable end has an exterior-end brick chimney.

There are no significant outbuildings on the property.




