DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This farm complex is located near Lappans Crossroads, west of Maryland Route 65, and south of Maryland Route 68, in Washington County, between Hagerstown and Sharpsburg. It stands on high ground and faces east.

The house is a two story, seven bay stone structure covered with rough cast or stucco. Its two southern bays are recessed beneath a double porch which is included under the main roof span. The first story of this porch has been enclosed with modern siding.

The house is large with windows and doors aligned with each other but widely spaced. All windows have narrow frames and most retain hinge pins for shutters. At the front elevation nine over six light sashes are used at the first story windows. Other windows have six over six light sashes. The principal entrance is centered in the north section of the front elevation, where an eight panel door is hung beneath a plain transom. Other entrances in the rear wall do not have transoms. Doors are also located at both levels of the recessed porch. The upper level of the porch is partially enclosed by a Victorain scroll cut balustrade.

Standing seam sheet metal forms most of the roof. Brick chimneys are located inside the e walls and at the interior of the house where the recessed and main sections join. The north end chimney is of brick, stuccoed and painted red.

The interior of the main or north section is bisected by a central stair and entrance hall. Several fireplaces in the house are placed diagonally at corners of the rooms. Mantel pieces have decorative reeding.

The property contains 42 acres and is part of the land grant, the "Resurvey on Charlemont." The house appears to be in good condition. Behind it are a barn and other agricultural out-buildings.

STATEMENT OF SIGNIFICANCE

This farm is significant as a representative of Washington County's vernacular architecture. The house, a stuccoed stone structure, is large and displays several important regional characteristics such as construction with stone, a five bay central entrance facade unit, a recessed double porch and the use of diagonally placed corner fireplaces at the interior. Corner fireplaces have been associated with late 18th century houses in this area. Decorative reeding on the mantels suggest Federal influence and late 18th or early 19th century work.

The history for this property can be traced as far back as February 29, 1840 when Joseph and Catherine Emmert sold it to Isaac Emmert, (WV/105). The Emmert family owned an extensive amount of land in the Lappans-Tilghmanton areas. At that time the farm had 170 3/4 acres and it retained that acreage until 1949. A daughter of Isaac Emmert married Daniel Wolf who acquired this property in 1842, (22/922). The farm remained in the Wolf family until 1899 (IN6/531, 88/382, 109/559). They also owned extensive amounts of land in the area.

The Sharpsburg-Hagerstown Pike, Maryland Route 65 which passes some distance in front of the house, was a public thorofare during the second quarter of the 18th century.
