DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This Washington County farmhouse is located on the east side of Alternate Route 40 at Kline's Mill near Benevola. It faces south toward the Little Beaver Creek which flows to the southwest beyond a small meadow.

The house is a three-bay, two-story stone dwelling with a two-story stone and frame el projecting from the west end of its north side. It is trimmed in black and white.

The walls are constructed of roughly coursed local fieldstone. More finely coursed stone work is evident in the east wall of the rear projection. Decorative work associated with the walls consists of flat stone arches over the first floor windows of the main section and the second story and attic openings at the gable ends. A date stone is set into a small brick-lined arch in the east gable.

Windows are located on all sides of the house except for the north gable end of the projection. All window sashes, which appear to date from recent restoration work, contain nine-over-nine panes, and are sympathetic with the original design of the house. Small four-light openings are present at the attic level. Openings into the basement are partially concealed by the grade level. On all windows the framing is plain. Windows of the first story are longer than those of the second floor and are flanked with paneled shutters. The shorter second story openings have louvered shutters.

The doors are simple in design with plain molding. The main entrance is situated in the center bay of the facade and is topped with a narrow transom. Other doors are located at the rear of the house opposite the main entrance and in the south bay of the west gable end. A door to the basement is located in the west bay of the facade. Doors are located in each side of the projecting el.

None of the three porches now present appears to be original. A narrow shed roof entrance porch shields the front door. It is supported by square wooden posts resting on high stone foundations. Another porch, four bays in length extends along most of the west side of the house. It, too, is supported by wooden posts with chamfered edges. The owner of the property has stated that the porches and the frame second story of the wing were added by his father ca. 1910.

The gable roof appears to date from the early 20th century. It is covered with modern grey shingles and overhangs the ends of the structure by several inches. The cornice which is probably contemporary with the roof consists of a rather broad band of molding.

Chimneys are located inside the east gable end and outside the north gable end of the wing. The flue attached to the el appears to be modern.

The date stone in the east gable end of the house indicates that it was built in 1791. The initials AVS appear above the date. During the 18th and early 19th centuries, the property belonged to a family by the name of Eavey (also spelled Avey and Evey). The letters AVS have been explained as designating the name Avey. The property contains 144.80 acres and is used for agriculture. The house is in excellent condition, having been restored in 1966 by the present owner who consulted with Ted Englehardt of Silver Spring, Maryland.

Located on this property, between the house and Alternate Route 40 is the 64 mile stone of the National Road.

STATEMENT OF SIGNIFICANCE

The major significance of this house is its architecture. It provides a documented and well maintained example of an 18th century building, few of which remain in Washington County. Although the porches and roof of the structure are not original, the exterior fabric of the building does remain essentially intact, leaving a record of late 18th century vernacular building technique.

This dwelling may be termed "vernacular" since its construction does not conform to any particular design or style. The house does not appear to have been built with great aesthetic striving, but rather, for the primary purpose of providing shelter. The result is a dwelling of a form which was functional for the 18th century, with decorative work present only in the flat stone arches over the windows.

The Eavey family, who emigrated from Holland, owned land in Washington County at an early date. A tract called "Avey's Delight and Resurvey" containing 450 acres, was granted to John Avey on August 19, 1751. In June of 1769, he was granted another tract, "Avey's Good Luck" which contained 453 acres.<sup>1</sup> Deed records indicate that the house is probably situated on one of these two tracts. The Kline family acquired the property in 1845.

Another significant feature of this property is the presence of the National Road milestone, located between the house and Route 40A. Although several of these markers remain between Boonsboro and Hagerstown, the 64th milestone is prominently placed and easily seen from the road. Also near the dwelling is the stone arch bridge which carries traffic across the Little Beaver Creek. The undated bridge is considered in form WA-II-042. The house, milestone and bridge located on this property provide a valuable record of several aspects of Washington County's early life.

In 1814 a land transaction occurred from Henry Avey to Christian Avey which included 170 acres, part of "Resurvey on Avey's Delight" (Liber Z, Folio 520). Other land exchanges among members of the Avey family took place in 1814, involving parts of "Avey's Good Luck" and the "Resurvey on Stull's Forest."
