**Description of Property and Eligibility Determination:** *(Use continuation sheet if necessary and attach map and photo)*

The Strother house is a 2-story, 4-bay single family stone residence located on MD 66 about 3 miles north of Boonsboro. The one story, full width front porch boasts seven simple wood columns. The 4-panel wood entrance door is off center and has a 4 light transom above. The windows are six over six panes double hung wood windows. There is a 1-story stone addition on the rear that appears to be a later addition. Also located on the property are a frame bank barn and a stone springhouse typical of mid-late 19<sup>th</sup> century farmsteads.

According to the tax records the Strother house was built in 1840. A structure appears in this location on the 1877 Atlas of Washington County as the property of A. Funk. At the time of the original MHT survey the farm was owned by William Strother and included 131.18 acres. The property now includes 5.73 acres.

The Strother house is a good example of a mid-19<sup>th</sup> century stone farmhouse that is significant for its architecture and association with the history of agriculture in Washington County. Retaining integrity of location, design, setting, materials, workmanship, felling and association, the Strother house is eligible for the National Register of Historic Places under Criteria A and C. The spring house and frame bank barns are contributing resources to the property and the National Register Boundary should include the entire tax parcel.

The property is not known to be associated with the lives of persons significant in the local, state, or national past (Criteria B). Nor is the property likely to yield information important in local, state, or national prehistory or history (Criteria D).

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This house is located along the north side of Maryland Route 66 about 3 miles north of Boonsboro in Washington County. It is situated on a rise of ground above a small spring and faces south or toward the road.

The structure is a two-story, four-bay stone dwelling with white trim. The walls are of roughly coursed and rubble local fieldstone, with carefully cut corner blocks or quoins. There is no decorative stone work associated with the exterior of the house.

The windows are generally spaced evenly in the walls. Six-over-six pane double hung sashes, held within narrow frames with mitered corners. Wide wooden sills are present at the bottoms of the windows. Small four-light openings light the attic.

The main entrance is located in the second bay from the north end of the house. The doorway is very simple in appearance and is framed similarly to the windows. A four-light transom is present above the door.

The roof is covered with green asphalt shingles. Its framing extends for several inches beyond the end walls of the house with simple molding finishing the eaves. Brick chimneys rise from inside each gable end.

A one-story porch which appears to date from the early 20th century extends along the length of the front elevation and the south bay of the north gable wall. It is supported by doric style pillars under a decorated frieze. A one-story shed roof porch extends along the rear of the building.

A one-and-a-half story three-bay spring house is located a short distance west of the main house. It is constructed of slightly coursed local fieldstone and has a roughly finished interior. A brick chimney rises from inside the south gable end. Nearby is a small stone smoke house in deteriorated condition.

The main house is in good condition and stands on a tract containing 106.70 acres.

**STATEMENT OF SIGNIFICANCE**

The area of significance of this house is its architecture. A four-bay stone structure with an off-center front door, it represents a major architectural group in Washington County and the Cumberland Valley. Many such dwellings date from the first half of the 19th century.

Although the specific building date of this farmhouse is not known at the present time, its appearance would suggest that it may have been constructed during the second quarter of the 19th century.




