**Description of Property and Eligibility Determination:** *(Use continuation sheet if necessary and attach map and photo)*

The Machet House is located on the east side of MD 66 about three miles north of Boonsboro. This 2-story, 3-bay side gabled log structure was encased with brick at one time; however, many of the bricks are missing or have been removed exposing the log construction. According to the tax records the house was built in 1848. A structure appears in this location on the 1877 Atlas of Washington County as the property of A. Funk who also owned the farm (WA-II-063) directly north of this structure.

The front of the house faces south and has a one story, entrance porch on the west side. The original entrance has been covered by the 1-1/2 story board and batten addition on the east side of house. According to the MHIP form, the addition at one time had a shed roof porch along the east side which has since been enclosed. The windows are six over six panes double hung wood windows with exterior storm windows. The roof is a corrugated metal roof.

The Machet House represents a type of construction prevalent in Washington County from the settlement period to the late 19<sup>th</sup> century. The structure is unusual, however, because it was encased with brick opposed to weatherboard. Despite its condition, the Machet House retains enough integrity of location, design, setting, materials, workmanship, feeling and association to be eligible for the National Register of Historic Places under Criteria C. It is recommended that the National Register Boundary include the entire tax parcel which is 3.91 acres. The property is not known to be associated with events that have made a significant contribution to the broad patterns of local, state or national history (criteria A). The property is not known to be associated with the lives of persons significant in the local, state, or national past (Criteria B). Nor is the property likely to yield information important in local, state, or national prehistory or history (Criteria D).

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This house is located along the east side of Maryland Route 66, about 3 miles north of Boonsboro in Washington County. It is situated along the edge of the road with its west gable facing the road.

The building is a three-bay, two-story brick dwelling, painted red with white trim. One story additions from various periods extend to the south of the main structure.

The walls are set on limestone foundations. Bricks are laid in all stretcher bond and encase a log structure. Large and irregular in size, the bricks are said by the owner to have been made on the property. At the east gable end of the house the brick wall terminates above the second story. The gable is finished with weather board siding.

Window and door openings are located at random in the walls. Some effort at symmetry in window placement has been made, however, in the north and west walls. Windows contain six-over-six light double-hung sashes set within wide architraves finished with quirked quarter round molding. Heavy wooden lintels are present over the windows. Small six-light windows in the west gable illuminate the attic.

The main entrance has been enclosed by an addition to the building. A door in the west bay of the south side of the house is simply framed and topped with a narrow transom.

The roof is covered with corrugated sheet metal. Brick chimneys rise from inside each gable end. The ends of the roof at the gable are finished with a tapered barge board that narrows to the roof peak. The cornice consists of eaves boxing finished with a band of molding. A one-story shed roof porch supported by chamfered posts extends along part of the south wall. A large stone chimney is located a short distance from the east end of the house.

The interior of the house is divided into three rooms at the first story. Original interior doors have six raised panels. Interior partitions at the second story are of tongue and groove boards. The owner has stated that part of what is believed to be a Civil War saber protrudes from the inside wall in the southwest corner of the house.

The house is in good condition and stands on property containing about four acres.

STATEMENT OF SIGNIFICANCE

The major significance of this house is its architecture. It is worthy of note as an example of a log dwelling which has been encased with brick. The appearance of the interior of the building would suggest that it is early; however, a detailed examination of its interior and exterior is necessary for an estimate of its age.

The property has remained about the same size since 1854 when Anna Gantz sold 3-3/4 acres and 15 perches of land to Andrew and Susanna Emmert for \$1,000. The price has varied little to the 20th century. Deed records prior to 1854 cannot be found.

Log structures are a significant architectural type in Washington County dating from the earliest days of settlement to late in the 19th century.






