DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This house is located along the north side of Beaver Creek Church Road about one mile north of Beaver Creek Road in the Beaver Creek area of Washington County, Maryland. It is situated on a rise of ground above the Beaver Creek and faces south or toward the road.

The structure is a two-story, three-bay brick dwelling with black and white trim. It is set on low limestone foundations.

The walls are of brick laid in common bond on all sides of the house. Generally, five courses of stretchers are used between rows of headers. Decorative work associated with the walls includes flat arches over openings.

Windows appear to be placed evenly in the walls. They contain two-over-two pane double-hung sashes held within narrow frames over wide wooden sills. Windows of the front elevation are flanked by louvered shutters.

The main entrance is located in the center bay of the facade. The doorway is simple in appearance and is topped by a two-light transom. Long louvered shutters are present at the entranceway.

A three-bay, one-story porch with a flat roof extends along the front wall of the house. It is supported by round pillars and has a decorated frieze.

The roof is covered with sheet metal. Small brick chimneys rise from inside each gable end.

The house is in excellent condition.


