DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This house is located along Beaver Creek Road about one mile east of Dunkard Church Road in Washington County, Maryland. The house is situated on a rise of ground above the Beaver Creek and faces southwest or toward the road and the creek.

The house is a two-story, three-bay stone dwelling with a one-story three-bay log section extending to the northwest. Exterior woodwork has been painted white.

Walls of the main section of the structure are of coursed local fieldstone at the facade with more roughly coursed stones composing the end and rear walls. There is evidence of considerable repointing. At the front elevation, windows at the first story are topped with two large block-like stones flanking a smaller stone somewhat like a keystone. A broad stone lintel is present over the main entrance.

Windows contain six-over-six pane double-hung sashes, many of which appear to have been replaced. The sashes are held within narrow frames finished with a bead. Openings in the log section display wider trim.

The main entrance is located in the northwest end bay of the front wall. The entrance way is quite simple in design, topped with a plain four-light transom. The treatment of the woodwork is similar to that of the windows. The jambs show raised panels while the door has six low relief panels. Another very plain entrance is located in the end bay of the front wall of the log section.

The roof is covered with corrugated sheet metal except at the front slope of the log section where shingles are present. Brick chimneys are present inside the southeast gable end of the stone section and inside the northwest end of the log portion. The eaves are finished with plain boxing while the roof at the gables is finished with a barge set against the house wall.

The house is currently being refurbished and is in excellent condition. The property contains one acre.

STATEMENT OF SIGNIFICANCE

The area of significance of this house is its architecture. Located in the Beaver Creek area, it is one of several stone dwellings which appear to have been connected with several milling businesses which were operated by the McCoy and Newcomer families. Except for "Doub's Mill" (WA-II-090) located about a mile downstream, none of the mills are standing.

This dwelling is also important as a well preserved example of a type of house frequently found in Western Maryland and the Cumberland Valley. It is a half plan adaptation of formalized five-bay, center hall house derived from the Georgian period.

The area is also significant for its scenic value.


