DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

Crick Hollow Farm is located along the north side of Beaver Creek Road in Washington County, Maryland. It is situated on a rise of ground above the Beaver Creek and faces east or toward the creek.

The building is a two-story, four-bay stone dwelling with black and white trim. The facade wall is laid with roughly coursed rubble fieldstone while other walls display rubble stone. A two-story shed roof wing which shows more than one period of building extends to the rear or west of the structure. There is no decorative stone work associated with the exterior of the building.

Windows are present in all elevations of the house. At the north end of the house the pairs of openings are set well to the west side of the wall. First story windows of the main section of the structure contain nine-over-six light double-hung sashes. Windows at the second floor level have six-over-six pane sashes. All are held in pegged frames which are rather wide and are finished with a bead. The windows are flanked by paneled shutters at the first story and louvered shutters at the second floor level.

The main entrance is located in the second bay from the north end of the house. The entrance way is quite simple, holding a six-panel door under a narrow four-light transom with framing similar to that of the windows. A modern, one-bay entrance porch sheds the front door.

The roof is of corrugated sheet metal which terminates with a barge board set directly against the end walls of the building. Brick chimneys rise from inside each gable end and from inside the end of the el. A modern concrete block chimney is located at the exterior of the most recent section of the el.

At the facade the cornice is finished with symmetrically molded trim. Simple boxing finishes the eaves at the rear of the house.

Near the dwelling is a one-bay, one-and-a-half story spring house. Its pegged windows contain six-over-three light double-hung sashes at the main floor. The roof is of wooden shingles. A brick chimney rises from inside the west gable end of this structure where doors are located at both the ground and upper levels.

The house is in excellent condition and stands on property containing 23.52 acres.

STATEMENT OF SIGNIFICANCE

The area of significance of this house is its architecture. A four-bay stone structure with an off-center front door, it represents a major architectural group in Washington County and the Cumberland Valley. Many such dwellings date from the first half of the 19th century.

Although the specific date of the Crick Hollow farmhouse is not known at the present time, evidence that is available suggests that it was built early in the 19th century.

The owner has stated that according to tradition the house was built by the Funk family. Samuel Funk acquired the property from John Witmer and Peter Newcomer, executors for the will of Samuel Newcomer some time after his death in 1811. The property was in the Funk family until 1966 when it was purchased by the present owner.

25.02 acres, being parcel #1 of a deed from John Funk, Executor to Samuel Funk. The said Samuel Funk having theretofore departed this life, whereof the title of said property became vested in his grandson Roy C. F. Weagley, by his last will and testament recroded in Wills Liber I, Folio 527.

Will Liber I, Folio 527, Will of Samuel Funk, probated June 19, 1900.

Item 1: I also will and devise to my said wife the home farm whereon I now reside, on Beaver Creek on the "Lower Quarter," containing about 21 acres of land, more or less ... After the death of my said wife, I will and devise said home farm absolutely to my grandson Roy Weagley, son of my daughter Clara Weagley.



The property is described as part of the "Resurvey on Stull's Forest," 24-7/8 acres. "Whereas Samuel Funk, late of Washington County, deceased, did on the 9th day of June, 1827, and on the 3rd of June, 1830, execute a codicil to said last will and testament leaving the aforesaid John Funk, the executove of said last will and testament ... and the said Samuel Funk thereby directs the sale of his real estate and the conveyance of same by his said executor ... Parcel 1 beginning for the first part at a stone on a hill in the public road leading from Doub's Mill to Hagerstown, it being the beginning of Samuel Funk's part of the "Resurvey on Stull's Forest" conveyed to him by John Witmer and Peter Newcomer executors of Samuel Newcomer, deceased.

Will Liber B, Folio 334, Will of Samuel Newcomer, probated May 25, 1811

The will stipulates taht Samuel Newcomer's plantation be sold six years after his death.
