DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

This house is located along the south side of Beaver Creek Road at the intersection of Beaver Creek Church Road in Washington County, Maryland. It is situated on a rise of ground and faces east with its north gable wall parallel to Beaver Creek Road.

The structure is a two-story, four-bay stone dwelling with white trim. A stone end frame el extends to the rear or west of the house.

The walls of the house are constructed of coursed local fieldstone. No decorative stonework is apparent over the window or door openings.

Windows have wide wooden frames and contain single-pane double-hung sashes. Paneled shutters flank the lower story windows while paneled shutters are present at second level openings. A two-story, three-sided projecting bay is present in the east wall. Decorative panels are present beneath the windows in the projection.

The main entrance is located in the west bay of the north gable end. The entrance way is rather elaborate in appearance with decorative paneling at the jambs and beneath the sidelights. Other entrances are located in the second bay from the north end of the east wall and in the north wall of the el.

A one-story porch extends along the east, north and past of thw west wall of the house. It is supported by plain Ionic style pillars.

The roof extends for several inches beyond the end walls of the house with the cornice work and barge containing several bands of molding.

The house is in excellent condition and stands on a tract containing 9.95 acres.

**STATEMENT OF SIGNIFICANCE**

The area of significance of this house is its architecture. It is one of a number of stone dwellings located in the Beaver Creek area. Although this house is a much altered example of Beaver Creek's stone structures, it is representative of a major architectural group in the area.

The house is located on property that was known as the John Funk Farm which was sold to Clara E. Weagley in 1899. The house was in the Weagley family until 1972.

The owner reports that the house is said to have been built by a member of the Funk family during the late 18th or early 19th century.
