This Maryland Inventory of Historic Properties (MIHP) Addendum was prepared in accordance with the Memorandum of Agreement (MOA) negotiated among H.B. Mellott Estate, Inc., the Water Management Administration Mining Program Maryland Department of the Environment, and the Maryland Historical Trust. A stipulation of the MOA required that an MIHP Addendum be prepared for each of the 14 properties nearby to the John Lung Farmstead (WA-II-149), which have a history or potential significance similar to the John Lung Farmstead.

This Addendum includes the property name, address, MIHP number, and a brief, one-to-two sentence comment on the property's condition, and one or more black and white photographs. Each photograph was printed in accordance with the photography requirements of the Maryland Historical Trust. The field survey and photography were conducted from the public right-of-way.

The Jacobson House was no longer extant in April 2007.

DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

This house is located along the north side of Mt. Aetna Road, at the east end of Mt. Aetna about 1/4 mile east of Maryland Route 66 in Washington County, Maryland. It is situated at the edge of the road and faces south.

The structure is a one-and-a-half story two-bay stone dwelling covered with thick yellow paint and thin stucco. The walls are constructed of uncoursed and roughly coursed fieldstone.

The few windows appear to have been placed at random in the walls. They have narrow frames which appear recent. The first story windows contain three lights over single-pane double-hung sashes while the upper half story windows display two-over-two light sashes.

The main entrance is located in the east bay of the front elevation near the center of the wall. It is treated simply and is trimmed similarly to the windows. The entranceway is topped by a modern bracketed hood.

The roof is covered with asphalt shingles. The eaves are finished with simple boxing. Small brick chimneys with corbels at their tops are located inside each gable end.

The interior of the house appears to have been altered completely with most work being characteristic of the ca. 1900 period. There are no fireplaces in the house.

The house is in fair to deteriorated condition and stands on a tract containing .892 acres.

STATEMENT OF SIGNIFICANCE

The architectural significance of this house is greatly diminished by the extensive exterior and interior alterations of the early 1900's. The house does, however, appear to be one of older structures in the Mt. Aetna area and derives significance from its association with the Mt. Aetna iron works.

Although it is extremely difficult to estimate the age of this house, it is possible that it is the only remaining structure in the furnace complex.

The importance of Mount Aetna Furnace lies in its contribution to industry in the Colonies and early republic as well as its role in providing weaponry to the American army during the Revolution and probably also during the war of 1812.

The furnace was built and run by the Hughes family who were major suppliers of arms to the Revolutionary Army. According to the Robbins report, the Hughes operation which consisted of several furnaces and forges was the largest military iron producing facility in Maryland.¹ The Hughes' owned a large tract of land called Mount Aetna which contained 4,482 acres and was resurveyed on November 30, 1787.² No date has been found for the original patent of the tract.

Samuel and Daniel Hughes, who were instrumental in supplying Washington's Army with weapons, were the sons of Barnabas Hughes who emigrated from Ireland in 1750 and settled near Lancaster, Pa. After moving to Baltimore, Barnabas relocated in Western Maryland where he began a prosperous iron business. He built Mount Aetna and other furnaces near the Black Rocks above the Beaver Creek.³ He died in 1780. During the Revolution, the furnace was run by Samuel and Daniel Hughes. It remained in the Hughes family until 1827 when it was purchased by John Horine. The association of the Hughes brothers with the American War for Independence attaches additional historical importance to the furnace.

Although little remains to verify its existence, the Mount Aetna Furnace site should be marked to commemorate its role in the important early American iron industry and its military significance in the American Revolution. The site is definitely worthy of further research and examination.


