

Description of Property and Eligibility Determination: *(Use continuation sheet if necessary and attach map and photo)*

300 N. Main Street is a one-story brick ranch house with Tudor-revival details. The central eave-front section is bracketed by two gable-front bays; on the north is a gable front bay with a clipped-gable entrance vestibule set into the south side; on the south is a clipped-gable-front bay. Both bays have paired 1/1 sash windows. The stretcher-bond brick is accented with randomly-placed stone blocks. A large picture window is set into the central portion of the house and is framed with stone quoins. There is an interior chimney on the front slope of the house. West of the house is a gable-front, brick two-car garage with a small buttress motif. The house dates to the 1940s. It is a non-contributing resource to the Town of Boonsboro Historic District (outside period of significance) and not individually eligible.



