Description:

The Kline Residence was originally constructed around 1894 to serve as a white school for the Mt. Aetna area, and continued at this capacity through at least 1930. In 1938, the property was sold by The Board of Education, to Melvin and Edna Bohn who likely converted the school to a residence. Currently the structure serves as a single-family residence.

The Kline Residence stands in the northeast quadrant of the MD 66/Mt. Aetna Road intersection in the area known as Mt. Aetna in Washington County, Maryland. It consists of a single story, rectangular, gable front vernacular structure. Currently asbestos shingles cover much of the exterior and the roof is a combination of standing seam metal and rolled asphalt roofing. A stone foundation and wood clapboard siding are visible under the shingle siding. The residence faces southwest on its lot and has a modest setback from the adjacent roadways. A paved driveway leading from Mt. Aetna Road to a detached garage stands east of the residence.

Significance:

The Kline Residence represents standard design for one-room schools in Washington County. The property retains its original location, setting, and design, and some materials and workmanship.

The Kline Residence consists of a single-story, rectangular, gable-front vernacular structure. Currently asbestos shingles cover much of the exterior and the roof is a combination of standing seam metal and rolled asphalt roofing. A stone foundation and wood clapboard siding are visible under the shingle siding. The residence faces southwest on its lot at the intersection of MD 66 and Mt. Aetna Road. It has a modest set back from the adjacent roadways and is surrounded by grass, with three bushes at the main façade and a row at the rear of the residence. A paved driveway leading from Mt. Aetna Road to a detached garage stands east of the residence.

On the residence, the façade contains a centered door flanked by 2/2 windows. Also, a small opening in the gable has been covered by plywood. A narrow concrete porch extends across the entire façade, with a standing seam metal shed roof supported by six, plain, square wooden posts. The two side elevations each contains three evenly spaced 9/6 windows and a brick chimney. At the east elevation, a bulkhead door provides access to the basement. At the rear of the residence, a shed roof, enclosed porch attaches to the original structure. The porch consists of wood clapboards and a standing seam metal roof, with six 1/1 windows. A nine-pane door provides access from the porch to the adjacent driveway. A concrete block chimney stands at the west corner of the addition, and a four-pane fixed window occurs in the gable of the original structure.

The garage consists of a single-story, gable-front structure with two wooden doors occupying the façade. The gable on the façade is covered by asbestos shingles and contains a small door opening. Vinyl siding covers the remainder of the garage structure.

The Kline Residence was originally constructed around 1894 to serve as a white school for the Mt. Aetna area, and continued at this capacity through at least 1930. In 1938, the property was sold by The Board of Education, to Melvin and Edna Bohn who likely converted the school to a residence. Currently the structure serves as a single-family residence.

The Kline Residence stands in the northeast quadrant of the MD 66/Mt. Aetna Road intersection in the area known as Mt. Aetna in Washington County, Maryland. Washington County was established on September 6, 1776 by an act of the Provincial Convention of Maryland. Previous to that time, from the organization of Frederick County in 1748, it had been a portion of that county. It is unknown exactly when and where the first settlement in Washington County occurred. The Lords Proprietary initiated surveys and began granting lands to individuals as early as 1732. These first settlers were chiefly Germans, with a few English, and they settled on large tracts of land. The area known as Mt. Aetna, initially comprising 4482 acres was granted to Daniel and Samuel Hughes in the mid-late 1700s.

The Hughes brothers were involved in iron manufacturing and were considered the most conspicuous manufacturers in the County. They operated furnaces at Hampton before shifting their operation to Black Rock, South Mountain and the Mt. Aetna area. The Mt. Aetna Furnace was located on the south side of the current Mt. Aetna Road. The Hughes became large landholders in the area, owning at least 12,373 acres in the vicinity. Most of this acreage was woodland that provided the large quantities of charcoal consumed by the blast furnaces. Food for the workers was also raised on the land as Mt. Aetna evolved from a factory center to an isolated community for the furnace employees.

The Revolutionary War created lots of work for the Mt. Aetna Furnace as the Hughes brothers sought and received contracts from Maryland and the Continental Congress in Philadelphia to cast cannon. Cannon production began during the winter of 1775-76 and continued until mid-1781. Following work for the Revolutionary War, Mt. Aetna continued as a successful venture throughout the War of 1812, yet operations ceased by 1820 and the Hughes began selling their Mt. Aetna land. William Price and Franklin Anderson acquired much of the Mt. Aetna estate in the mid-1820s. In 1827, they sold most of these lands (1,100- acres) to John Horine. Horine also obtained portion of adjacent grants such as "Resurveyed on Adventure" and "Resurveyed on Discontent." Horine's property included much of the project area except the northwestern quadrant of the intersection, and the original Mt. Aetna tract remained intact through the early twentieth century. Other Horine land was parceled and sold much

sooner as the area developed as an agricultural area and a crossroads community although the area was never heavily developed. However in 1922, Elder Fleagle moved to the area and attempted to develop Mt. Aetna as a residential area. Fleagle and his Seventh Day Adventist Congregation built the Highland View Academy (now the Mt. Aetna Elementary School) and they did manage to develop a "well-paved conglomeration of lovely homes, two schools, and an independent water supply." This development occurred east of the project area.

The establishment of an education system in Washington County didn't begin taking shape until 1800. At that time parents who could afford to, would send their children to boarding schools outside of the county while others depended on private tutors or themselves, and some area residents would band together to hire a teacher to open a "neighborhood school." A public school system was formally established in Washington County on July 11, 1865 when the first Board of School Commissioners held its initial meeting. At that time, there were 123 schools in the county with a total enrollment of about 4,900. From 1865 to 1900 school attendance increased almost 25%. The substantial and continuous increase in enrollment, attendance, and schools offered evidence that the school system in Washington County had secured the interest and support of the public.

Beginning in 1865, the State Board of Education required that all public schools be built from plans on files in the State Superintendent's office or from plans submitted by the County Board and approved by the State Superintendent of Public Instruction. In Washington County, in 1865, the president of the County Board stated that the majority of the schoolhouses were poorly built, badly located, and unfit for the purposes designated. As a result the county undertook a building campaign, with the greatest expansion in the building program occurring in the period from 1867 to 1876. These early schools were one-room designs. As enrollment and attendance increased, two and three room school designs were developed. In Washington County, as late as the 1930s, the majority of schools in the system were one room. However, the number of three or more room structures was rapidly increasing and as pupil mobility improved, a single larger structure would often replace a few one-room structures in an area. This was especially true following the introduction of the school bus.

National Register Evaluation:

The Kline Residence represents standard design for one-room schools in Washington County. As such, it is eligible for the National Register of Historic Places. The property retains its original location, design and settings, and some materials.

The Kline property is associated with the Washington County school system and the development of the Mt. Aetna area. However, it was not constructed during the school boom period, and since its conversion to a residence it can't convey its connection to the system. In addition, its construction does not coincide with the furnace period or the development by Elder Fleagle, the two prominent events associated with the development of Mt. Aetna. Therefore, the property does not possess an association with significant events or trends, and is not eligible under Criterion A. Research into the construction of the building and the tenants does not identify any known association with significant persons; rendering the property not eligible under Criterion B. Similarly, the property has no known potential to yield important information, so it is not eligible under Criterion D, and the seven criteria considerations do not

apply.

While the property does not possess significance under Criteria A, B, or D, it is eligible under Criterion C because it embodies distinctive characteristics of a type of architecture. The Kline Residence is an excellent example of the Washington County one-room schoolhouse and one of only a handful remaining relatively unaltered in the county. A review of a 1915 photograph of the school reveals only minor alterations to the original structure. Changes to the original structure include the addition of windows on the façade, the extension of the front porch to cover the entire façade, the construction of the rear porch extension, the addition of chimneys, and the installation of asbestos shingle siding. The structure does retain the original windows, an unusual style that appeared on various schools in the county, and the original siding material remains under the shingle siding. The county no longer owns any one-room schoolhouses and only a few are known to remain in existence; most of which suffer substantial design additions due to new uses. While the Kline Residence has lost some integrity of materials and design, it does retain more than other existing schools. In addition, the Kline Residence retains the aspects of location, setting, workmanship, and association. Overall, the property retains the integrity and ability to convey its significance as a Washington County one-room schoolhouse and given these considerations, the Kline Residence stands as a rare example of this type of structure.




