Based on the available information, the Pat Holland Property is eligible for the National Register of Historic Places under Criterion C for architecture. The frame house with frame summer kitchen is a good example of an intact mid- to late- 19th century farmstead in southern Washington County. The detailing reflects the Victorian period. The off-center placement of the door suggests a German influenced plan common in this part of Maryland. The house and setting appear to retain good integrity. A 20th century outhouse and heavily altered barn are also present on the property, but do not contribute. The property was requisitioned for use as a hospital and field office during the Battle of Antietam.





